3 Resolution approving Amendment No. 2 to the agreement between The Regents of the 4 University of California and the Department of Public Health, for behavioral health 5 services for adults and older adults, to increase the agreement by \$63,722,165 for an 6 amount not to exceed \$86,533,675; to extend the term by five years, from June 30, 2022, 7 for a total agreement term of July 1, 2018, through June 30, 2027; and to authorize the 8 Department of Public Health to enter into amendments or modifications to the contract 9 prior to its final execution by all parties that do not materially increase the obligations 10 or liabilities to the City and are necessary to effectuate the purposes of the contract or 11 this Resolution.

13 WHEREAS, The Department of Public Health (DPH), in order to provide behavioral 14 health services for adults and older adults residing in San Francisco, conducted three 15 Request for Proposals (RFP) processes in 2016 and 2017, for Substance Use Disorder 16 Treatment Services and Support, RFP 26-2016, Mental Health Outpatient Programs for 17 Adults/Older Adults, RFP 8-2017, and Intensive Case Management, RFP 11-2017 awarding a 18 contract to provide these services to the Regents of the University of California; and 19 WHEREAS, The Board of Supervisors approved the contract agreement between DPH 20 and the Regents of the University of California for an initial contract term of four years from 21 July 1, 2018, through June 30, 2022, in an amount not to exceed \$22,811,510 through Resolution No. 293-18 (File No. 180716); and 22 23 WHEREAS, The DPH subsequently amended the contract agreement to add the 24 Citywide Linkage program funded by Mental Health State Homeless Mentally III Outpatient

Treatment grant funding, and to update standard contractual clauses, while retaining the term
of July 1, 2018, through June 30, 2022, and the not to exceed amount of \$22,811,510; and
WHEREAS, DPH wishes to amend the agreement to continue providing behavioral
health services for adults and older adults in alignment with the length of the term anticipated
in RFP 11-2017, RFP 8-2017, and RFP 26-2017, by extending the term by five years, from
June 30, 2022, through June 30, 2027, increasing the contract by \$63,722,165 for a total
contract amount not to exceed \$86,533,675 and for a total agreement term of July 1, 2018,

8 through June 30, 2027; and

9 WHEREAS, Section 9.118 of the Charter requires approval of the Board of Supervisors 10 for contracts requiring anticipated expenditures exceeding \$10 million; now, therefore, be it 11 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public 12 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the 13 City and County of San Francisco, to execute Amendment No. 2 to the agreement with The 14 Regents of the University of California to provide behavioral health services for adults and 15 older adults for an amount not to exceed \$86,533,675 for a total agreement term of July 1, 16 2018, through June 30, 2027; and be it

17 FURTHER RESOLVED, That the Board of Supervisors authorizes the Department of 18 Public Health to enter into any amendments or modifications to the contract, prior to its final 19 execution by all parties, that the Department determines, in consultation with the City 20 Attorney, are in the best interests of the City, do not otherwise materially increase the 21 obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of 22 the contract, and are in compliance with all applicable laws; and be it 23 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed 24 by all parties, the Director of Health and/or the Director of the Office of Contract
