7	Francisco (collectively, "Contractor") for refuse collection services at City

10	for a total contract duration of three years and seven months of December 1,
11	2020, through June 30, 2024.

13	WHEREAS, The City has historically contracted with Contractor on a sole source
14	basis to provide refuse collection services at City facilities; and

15 WHEREAS, Pursuant to the sole source authority under Administrative Code

16 Chapter 21.5, the Office of Contract Administration entered into an Agreement with

17 Contractor dated December 1, 2020, for refuse collection services in the amount of

- 18 \$5,600,000 and for a duration of seven months to June 30, 2021, as amended by the:
- 19 First Amendment, June 29, 2021, which extended the end date to November 30,
- 20 2021, and increased contract not to exceed amount to \$9,900,000, and

Second Amendment, November 5, 2021, which extended the end date to June
30, 2022, and increased contract not to exceed amount to \$15,622,000, and
WHEREAS, The City's Refuse Ordinance does not prohibit the City from

24 competitively procuring refuse collections services for City facilities, and

WHEREAS, The Office of Contract Administration presently intends to issue a
 solicitation to competitively procure a new agreement for City refuse collection services,
 and

WHEREAS, The Office of Contract Administration seeks to enter into a Third
Amendment, increasing the not to exceed contract amount to \$42,100,000 and
extending the contract duration by two years to June 30, 2024, to meet City business
needs until a new agreement can be competitively procured, and

8 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to
9 approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and
10 WHEREAS, The Board of Supervisors approved Second Amendment to the

11 contract on November 16, 2021 by Resolution No. 532-21 (File No. 211083) to increase

12 the contract amount from \$9,900,000 to \$15,622,000 and extend contract from

13 December 1, 2021, to June 30, 2022; and

WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in
File No. 220422, which is hereby declared to be part of this resolution as if set forth fully
herein; now, therefore, be it

RESOLVED, That the Board of Supervisors, under Charter, Section 9.118(b),
 hereby approves the Third Amendment to the agreement with the Contractor, to
 increase the contract amount by \$26,478,000 for a total not to exceed contract amount
 of \$42,100,000, and to extend the duration by two years to June 30, 2024; and, be it
 FURTHER RESOLVED, That within 30 days of the Agreement being fully
 executed by all parties, the Purchaser shall provide the final Agreement to the Clerk of
 the Board for inclusion into the official file.
