4	Section 3. The San Francisco Public Works Code is hereby amended by adding Article
5	5.8, to read as follows:
6	ARTICLE 5.8 PERMIT REGULATIONS FOR MOBILE FOOD FACILITIES CONCERNING
7	PRODUCTS FOR HUMAN CONSUMPTION.
8	SEC. 184.80. DEFINITIONS.
9	For the purpose of this Article the following words and phrases mean and include:
10	(a) BART. San Francisco Bay Area Rapid Transit District.
11	(b) Department. The Department of Public Works.
12	(c) Director. The Director of the Department of Public Works or his or her designated
13	representative.
14	(d) Director of Health. The Director of the Public Health Department of the City and County of
15	San Francisco or a designated representative of the Director of Health.
16	(e) Location. A Mobile Food Facility location is a fixed point or defined route including an
17	approximate duration at specific fixed points and approximate time of day at specific fixed points along
18	the route.
19	(f) Mobile Caterer. Any motorized vehicle wherein or wherefrom wrapped food, foodstuffs,
20	products, liquids or material intended or food or drink for human consumption are sold, served,
21	distributed, or offered for sale at retail or given away to the public.
22	(g) Mobile Food Facility. Any vehicle or pushcart used in conjunction with a commissary or
23	other permanent food facility upon which food is sold or distributed at retail. Mobile Food Facility
24	does not include a "Transporter" used to transport packaged food from a food facility or other
25	

1	approved source to the consumer. For purposes of this Article, a pushcart or a mobile caterer are both
2	referred to as a Mobile Food Facility unless specifically stated otherwise.
3	(h) Mobile Food Facility Vendor. Any person or entity engaged in the business of operating a
4	Mobile Food Facility within the City and County of San Francisco.
5	(i) Person. An individual or natural person.
6	(j) Pushcart. Any wagon, cart, or any other food-serving device, whether stationary or
7	movable, wherein or wherefrom any food or foodstuffs are sold, served, distributed, offered for sale at
8	retail, or given away to the public, whether consumed at said pushcart or elsewhere.
9	(k) Pushcart Peddler. Any person or entity engaged in the business of operating a pushcart
10	within the City and County of San Francisco.
11	<u>SEC. 184.81. PERMIT REQUIRED.</u>
12	It shall be unlawful for any person, firm or corporation to engage in or carry on the business of
13	a Mobile Food Facility, or to operate, or cause or permit to be operated any Mobile Food Facility
14	upon any public street, sidewalk, alley, or any other public place in the City and County of San
15	Francisco, without first having obtained a permit from the Director accompanied by approval by the
16	Director of Health and the Fire Marshal. This Article shall apply only to Mobile Food Facilities on
17	public right-of-way under the jurisdiction of the Department of Public Works and as defined in Public
18	Works Code Section 2.4.4(t).
19	<u>SEC. 184.82. EXCLUSIONS.</u>

In order to operate the Pushcart, the Peddler shall first 11 obtain an annual Certificate of Sanitation from the Director of Health and pay Department of Public 12 Health fees as set forth in Section 184.83. 13 SEC. 184.83 MOBILE FOOD FACILITY APPLICATION AND FEE PROVISIONS. 14 (a) Every person desiring a Mobile Food Facility permit pursuant to this Article shall file an 15 application with the Director upon a form provided by the Director and shall pay a filing fee of 16 \$125.00, a notification fee of \$200.00, and an inspection fee of \$383.00 for a single Location for the 17 Mobile Food Facility. Each additional Location shall require payment to the Department of a 18 notification fee of \$200.00 per Location, an inspection fee of \$383.00 for the first additional Location 19 and an inspection fee of \$191.50 per each additional Location. Separate fees shall be paid to the 20 Department of Health and the Fire Marshal for the annual approvals required by each department for 21 a valid permit under this Article. The fees for the Department of Public Health are set forth in the 22 Business and Taxation Code. 23 (b) Half of the required fees for a single Location and half of the fees for any additional 24 Location(s) shall be paid at the time of application submission and the remainder of the total fee
- 25

1	amount shall be paid at the time of the Director's decision on the permit. No refunds are available if
2	the Department disapproves a permit or a Permit Location.
3	(c) Every Permittee desiring to change the Location of the Mobile Food Facility, modify the
4	hours of operation to allow service after 8 p.m., or add a new Location(s) during the term of the annual
5	permit, shall file an application with the Director upon a form provided by the Director and shall pay a
6	filing fee of \$85.00 for each Location change or addition of a new Location(s), a notification fee of
7	\$200.00 per Location, and an inspection fee of \$191.50 per Location. Such requests shall be processed
8	in the same manner as a new permit.
9	(d) Permit Renewal and Annual Renewal Fee. (1) Every Mobile Food Facility permit is
10	subject to an annual renewal filing fee of \$125.00 per permit. In addition, if during the course of the
11	preceding year the Department received one or more substantiated complaints against the permit
12	Location(s) or filed one or more notices of violation against the Permit, the Department shall assess an
13	additional processing fee of \$159.50 per permit. The Department also shall charge inspection fees as
14	follows: \$576.00 the first two (2) Locations where substantiated complaints were received or notices
15	of violation filed and \$288.00 per each additional Location where substantiated complaints were
16	received or notices of violation filed. Said fees are payable to the Department. Separate annual fees
17	shall be paid to the Department of Health and the Fire Marshal for the approvals required by each
18	department for a valid renewal permit under this Article. The annual renewal fees for the Department
19	of Public Health are set forth in the Business and Taxation Code.
20	(2) Any Mobile Food Facility permit that the Director renews is not final and effective unless
21	and until the Mobile Food Facility Vendor has obtained an annual renewal of his or her Certificate of
22	Sanitation for the Department of Public Health and approval from the Fire Marshal.
23	(3) The permit issuance date shall be when the permit is final and effective.
24	(4) Permits are automatically renewed each year so long as the Mobile Food Facility remains
25	in compliance with this Article. Renewal of the permit does not require notice under Section 184.88,

1	unless the permittee is changing the Location that the Mobile Food Facility serves, adding a new
2	Location(s), changing the hours of operation to serve a Location later than 8 pm, or making other
3	changes to the Mobile Food Facility that the Director determines requires public notice.
4	(e) The fees set forth in this Section are subject to the fee review and adjustment procedures of
5	<u>Section 2.1.2.</u>
6	(f) Each Mobile Food Facility shall require a separate permit pursuant to this Article. Each
7	permit issued pursuant to this Article shall be valid for only those Locations and hours of operation
8	that the Department approves as set forth in this Article.
9	(g) Notwithstanding Subsection (f), the Director may issue a single permit or permits to an
10	assigned Location(s) for multiple Mobile Food Facilities. The fees for such permit shall be the filing,
11	notification, and inspection fees for a single Location. Under such circumstances, Director also may
12	charge additional permit fees as set forth in Section 2.1.3. All Mobile Food Facilities operating under
13	a single Location permit shall comply with all other provisions of this Article.
14	(h) The Board of Supervisors reserves the right to charge a public right-of-way assessment fee
15	for occupation of the right-of-way by a Mobile Food Facility.
16	SEC. 184.84. MOBILE FOOD FACILITY APPLICATION FORM.
17	Except as otherwise provided herein, an application for a Mobile Food Facility permit pursuant
18	to the provisions of this Article shall specify or include:
19	(a) The name, business and residence address of the applicant and the address where the
20	mobile catering vehicle is stored during nonoperating hours. If the applicant is a corporation, the name
21	of the corporation shall be set forth exactly as shown in its articles of incorporation; the names and
22	residence addresses of each of the officers, directors and each stockholder owning more than 10
23	percent of the stock of the corporation. If the applicant is a partnership, the application shall set forth
24	the name and residence address of each of the partners, including limited partners. If one or more of
25	

1	the partners is a corporation, the provisions of this Section pertaining to a corporate applicant apply.
2	A natural person shall not acquire a stock interest in more than one corporate permittee.
3	(b) A description of the Mobile Catering Vehicle, including the following data: The make,
4	model and type of body; the number of cylinders; the vehicle identification number or any other
5	identifying number as may be required by the Director.
6	(1) If this information is not know at the time of permit application, this requirement
7	can be satisfied as a condition of obtaining a final and effective permit.
8	(c) Whether or not the applicant intends to operate a Mobile Food Facility under a fictitious
9	<u>name.</u>
10	(d) Such information pertinent to the operation of the proposed activity, including information
11	as to management and authority control, as the Director, Director of Health, or Fire Marshal may
12	require of an applicant in addition to the other requirements of this Section.
13	(e) The address to which notice, when required, is to be sent or mailed, and the name and
14	address of a person authorized to accept service or process, if not otherwise set forth herein.
15	(f) A photograph of the permit applicant.
16	(g) Whether the application is for a new permit, renewal of an existing permit, a change to the
17	Location that the Mobile Food Facility serves, a change in hours of operation, or the addition of a
18	Location(s).
19	(h) A description of the food product, products, services the applicant intends to sell.
20	(i) The specific Location(s) of the activity, including a detailed description of where the
21	applicant intends to place his or her Mobile Food Facility.
22	(j) The proposed hours of operation and days of operation for each Location that the Mobile
23	Food Facility proposes to serve.
24	SEC. 184.84.1. CORPORATE APPLICANTS; EXEMPTION.

1	The provisions of Sections 184.84 relating to requirements for corporate applicants shall not
2	apply to any of the following:
3	(1) A corporation, the stock of which is listed on a stock exchange in the State of California or
4	in the City of New York, State of New York.

23	The Director shall issue to each permittee an identification card which shall contain the number

2	the possession of the operator at all times during hours that the mobile catering vehicle is in operation.

9	(b) The permit, business license, decal confirming a valid Certificate of Sanitation,

11	Food Facility shall be displayed in a manner where it is in plain view of the public at all times.
12	SEC. 184.94. GOOD NEIGHBOR POLICIES. Mobile Food Facilities shall be managed in
13	accordance with the following good neighbor policies:
14	(a) The quiet, safety, and cleanliness of the Mobile Food Facility Location and its adjacent
15	area shall be maintained;
16	(b) Proper and adequate storage and disposal of debris and garbage shall be provided;
17	(c) Noise and odors shall be contained within immediate area of the Mobile Food Facility
18	Location so as not to be a nuisance to neighbors;
19	(d) Notices shall be prominently displayed urging patrons to leave the Mobile Food Facility
20	premises and neighborhood in a quiet, peaceful, and orderly fashion and to please not litter or block
21	driveways in the neighborhood; and,
22	(e) Employees of the Mobile Food Facility shall walk a 100-foot radius from the Location some
23	time within 30 minutes after closing and shall pick up and dispose of any discarded beverage
24	containers and other trash left by patrons.
25	SEC. 184.96. TRANSFER OF PERMIT.

1	No permit shall be transferable except with the written consent of the Director with the
2	approval of the Director of Health, such consent and approval shall not be unreasonably withheld. The
3	application for such transfer shall contain the same information as requested herein for an initial
4	application for such a permit and shall be accompanied by the same filing and inspection fees as for an
5	initial application. Upon approval of said transfer, the transferee shall retain the original permit

19	(5) The Mobile Food Facility Vendor habitually violates the Good Neighbor Policies set forth

21	(6) The Mobile Food Facility Vendor substantially modifies the food product, products, or
22	services the applicant intends to sell so that it duplicates the same type of food product or other
23	merchandise or similar service of a previously established business or Mobile Food Facility located
24	within 200 feet of the Mobile Food Facility.
25	

1	(7) The Mobile Food Facility has not operated in the permitted Location for a period of six (6)
2	months or more.
3	(b) The Director of Health also is authorized to revoke a Certificate of Sanitation if he or she
4	finds violations of the Health Code or State law regarding Mobile Food Facility uses. This revocation
5	may be in addition to or separate from any action that the Director takes.
6	<u>SEC. 184.98. PENALTY.</u>
7	(a) If the Director determines that the permittee has exceeded the scope of the permit, either in
8	terms of duration or area, or determines any other violation of the permit terms or conditions has
9	occurred, the Director shall order the permittee to correct the violation within a specified time period.
10	If any person has occupied public right-of-way without a permit, the Director shall immediately order
11	the violator to vacate the occupied area.
12	(b) Failure to pay any fee assessed under these provisions shall constitute good cause for
13	immediate revocation of the permit or removal of unpermitted obstructions.
14	(c) Criminal Penalty.
15	(1) Any person who shall violate any of the provisions of this Section shall be guilty of an
16	infraction at each location where such violation occurs. Every violation determined to be an infraction
17	is punishable by (A) a fine not exceeding \$100 for the first violation within one year; (B) a fine not
18	exceeding \$200 for a second violation within one year from the date of the first violation; (C) a fine not

1	(d) Civil Penalties. (1) The Director may call upon the City Attorney to maintain an action for
2	injunction to restrain or summary abatement to cause the correction or abatement of the violation of
3	this Article, and for assessment and recovery of a civil penalty and reasonable attorney's fees for such
4	violation.
5	(2) Any person who violates this Article may be liable for a civil penalty, not to exceed \$500 for
6	each day such violation is committed or permitted to continue, which penalty shall be assessed and
7	recovered in a civil action brought in the name of the people of the City by the City Attorney in any
8	court of competent jurisdiction. In assessing the amount of the civil penalty, the court may consider any
9	one or more of the relevant circumstances presented by any of the parties to the case, including, but not
10	limited to, the following: the nature and seriousness of the misconduct, the number of violations, the
11	persistence of the misconduct, the length of time over which the misconduct occurred, the willfulness of
12	the defendant's misconduct, and the defendant's assets, liabilities, and net worth. The City Attorney also
13	may seek recovery of the attorneys fees and costs incurred in bringing a civil action pursuant to this
14	Section.
15	(e) Administrative Penalty. In the alternative to the criminal or civil penalties authorized by
16	Subsections (c) and (d) of this Section, Department of Public Works officials designated in Section 38
17	of the Police Code may issue administrative citations for such violations. The administrative penalty
18	shall not exceed \$300 for each violation. Notwithstanding the above limitation, should a violation not
19	be corrected as the Director has ordered or in the case of occupation without a permit, the permittee or
20	person shall pay a penalty fee of up to \$1,000 per day for each day of violation. Such penalty shall be
21	assessed, enforced, and collected in accordance with Section 39-1 of the Police Code.

- 23 <u>SEC. 184.100. SEVERABILITY.</u>
- 24 If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Article or
- 25 *any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of*

1 competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining 2 portions of this Article or any part thereof. The Board of Supervisors hereby declares that it would 3 have passed each section, subsection, subdivision, paragraph, sentence, clause, or phrase thereof 4 irrespective of the fact that any one or more section, subsections, subdivisions, paragraphs, sentences, 5 clauses or phrases be declared unconstitutional or invalid or ineffective. 6 Section 4. The San Francisco Health Code is hereby amended by amending Sections 7 440 and 451, to read as follows: SEC. 440. - FOOD PRODUCT AND MARKETING ESTABLISHMENT. 8 9 (a) Food Product and Marketing Establishment means any room, or building, cart or 10 vehicle, except those peddler wagons used for peddling as defined in Articles 13, 17.2 and 17.3 of Part 11 II, Chapter VIII of the San Francisco Municipal Code, or place or portion thereof, maintained, 12 used or operated for the purpose of commercially storing, selling, vending, packaging, 13 making, cooking, mixing, processing, bottling, canning, packing, slaughtering, or otherwise 14 preparing or handling food, except Food Preparation and Service Establishments as defined 15 in Section 451 and Food Product and Marketing delivery vehicles. 16 (b) Food, as used in this Section, includes all articles used for food, drink, 17 confectionery, or condiment, whether simple or compound, including perishable foods, such 18 as fruits, vegetables, fish, meat, poultry, eggs, and bakery goods, whether sold after processing or sold in a fresh or frozen form. Food as used in this Section, shall not include 19 20 whole pumpkins sold during the month of October for purely decorative purposes, which are 21 not intended for human consumption, and which are clearly marked as being sold only for 22 such limited purposes. 23 (c) "Bakery" is included within this Section and means any room, building, premises, or

place which is used or operated for commercial baking, manufacturing, preparing, processing,
 retail selling, or packaging of bakery products. It includes all rooms of a bakery in which

bakery products or ingredients are stored or handled. It does not, however, include any Food
 Preparation and Service Establishment as defined in Section 451.

(d) It shall be unlawful for any person, persons, firm or corporation to maintain or
operate within any room, building, vehicle or place or portion thereof a Food Product and
Marketing Establishment within the City and County of San Francisco, without having first
obtained a permit issued and signed by the Director of Public Health of said City and County
to do so.

8 Said permit when issued shall be kept displayed in a prominent place on the premises9 of the establishment, vehicle or cart for which or whom it is issued.

## SEC. 451. FOOD PREPARATION AND SERVICE ESTABLISHMENT.

- (a) "Bar or tavern" means any food preparation and service establishment which
  primarily prepares and/or serves alcoholic beverages.
- (b) "Bed and breakfast establishment" means a "restricted food service facility" as
  defined in Health and Safety Code Section 113893.
- 15 (c) "Boardinghouse" means any building or portion thereof occupied or intended,
- 16 arranged or designed for occupation by six or more but less than 35 guests where sleeping
- 17 rooms and meals are provided to the guests for compensation and includes all private
- institutional type homes where inspection is made by the San Francisco Department of PublicHealth.

(d) "Caterer" means a person who is in the business of providing food, beverages, and
sometimes service, at social gatherings. The caterer prepares the food at a location separate
from the social gathering, though the caterer may engage in limited food preparation at the
location where the caterer serves the food. A caterer is not a private chef or chef for hire who
prepares food in a private home.

1 (e) "Catering facility" means any food preparation and service establishment where a 2 caterer prepares food for service at another location.

3 (f) "Commissary" means any food establishment in which food, containers, equipment, 4 or supplies are stored or handled for use in vehicles, mobile food preparation units, food carts, 5 or vending machines.

6 (g) "Director" means the "Director of Public Health of the City and County of San 7 Francisco" or his or her designee. "Inspectors" shall mean the "Inspectors of the Department 8 of Public Health," administered by said Director. The Director shall be responsible for the 9 administration and enforcement of Sections 451 to 456, inclusive, of this Article and the rules 10 and regulations relating thereto. The Director shall, after a public hearing, prescribe the rules 11 and regulations relating thereto. Said rules and regulations shall be issued in pamphlet form. 12 All such food preparation and service establishments shall be operated, conducted and 13 maintained in accordance therewith.

14 (h) "Food demonstrations" means any food preparation and/or service facility 15 operating out of temporary facilities approved by the Director of Public Health for a period of 16 time not to exceed seven consecutive days for purposes of demonstrating food preparation or 17 equipment.

18 (i) "Food preparation and service establishment" means and includes any restaurant, 19 *itinerant restaurant* mobile food facility, guest house, boardinghouse, special events, school food 20 concessions, bar or tavern, take-out establishment, fast food establishment, caterer, catering 21 facility, temporary facility, food demonstration, commissary, *pushcart*, stadium concession, 22 vending machine, bed and breakfast establishment, private school cafeteria, hospital kitchen, 23 and licensed health care facility, as those terms are defined herein.

24 (i) "Guest house" means any building or portion thereof occupied or intended, 25 arranged, or designed for occupation by 35 or more guests where sleeping rooms and meals

are provided to the guests for compensation and shall include "guest house," "residence
 club," "lodge," "dormitory," "residence cooperative" and any of its variants.

- 3 (k) "Hospital kitchen" means any food preparation and service facility operating within
  4 a hospital that serves food to staff or the general public, but not to patients.
- 5 (I) *"Itinerant restaurant" means any restaurant, operating from temporary facility, cart or*
- 6 *vehicle, except those peddler wagons used for peddling as defined in Section 132(a) and (b) of Part III*
- 7 of the San Francisco Municipal Code, serving, offering for sale, selling or giving away food or
- 8 *beverage, and includes, but is not limited to, facility or vehicle where only wrapped sandwiches or*
- 9 *other wrapped and packaged, ready-to-eat foods are served, and any mobile unit on which food is*
- 10 *prepared and served.*
- 11 (*m*) "Licensed Health Care Facility" means all of the following health facilities with 16 or
- more beds designated for the diagnosis, care, prevention, and treatment of human illness,
- 13 physical or mental, including convalescence, rehabilitation, and care during and after
- 14 pregnancy, to which persons are admitted for a 24-hour stay or longer:
- 15 (1) General Acute Care Hospital as defined in Cal. Health and Safety Code Section
- 16 1250 (a) or any successive statutes;
- 17 (2) Acute Psychiatric Hospital as defined in Cal. Health and Safety Code Section 1250
  18 (b) or any successive statutes;
- (3) Skilled Nursing Facility as defined in Cal. Health and Safety Code Section 1250 (c)
  or any successive statutes;
- (4) Intermediate Care Facility as defined in Cal. Health and Safety Code Section 1250
  (d) or any successive statutes;
- (5) Special Hospital as defined in Cal. Health and Safety Code Section 1250 (f) or any
  successive statutes;
- 25

- (6) Intermediate Care Facility/Developmentally Disabled as defined in Cal. Health and
   Safety Code Section 1250(g) or any successive statutes;
- 3 (7) Chemical Dependency Recovery Facility as defined in Cal. Health and Safety Code
  4 Section 1250.3 or any successive statutes;
- Any of the facility types listed above that are operated by the State of California
  Departments of Mental Health, Developmental Services, Corrections, or Youth Authority are
  not included in this definition.
- 8 (m) "Mobile Food Facility" means any vehicle or pushcart used in conjunction with a
- 9 <u>commissary or other permanent food facility upon which food is sold or distributed at retail. Mobile</u>
- 10 <u>Food Facilities may be located on private or public property.</u> Mobile Food Facility does not include a
- 11 <u>*"Transporter" used to transport packaged food from a food facility or other approved source to the*</u>
- 12 *consumer. There are five categories of Mobile Food Facilities for licensing and fee payment purposes*
- 13 <u>under San Francisco Business and Tax Regulations Code Section 249.1 as set forth below. For</u>
- 14 *purposes of this Section, the term "potentially hazardous food" shall have the same meaning as set*

- 20 <u>Vendor handles prepackaged and non-potentially hazardous foods, including but not limited to,</u>
- 21 *pastries, bagels, donuts, popcorn, chips, candies, sodas, or bottled drinks.*
- 22 (2) "Mobile Food Facility 2" means a Mobile Food Facility where a Mobile Food Facility
- 23 <u>Vendor handles prepackaged and potentially hazardous foods, including but not limited to, cold</u>
- 24 <u>sandwiches, salads, pasta, or cold noodles.</u>

1	(3) "Mobile Food Facility 3" means a Mobile Food Facility where a Mobile Food Facility
2	Vendor handles non-prepackaged and non-potentially hazardous foods, including but not limited to,
3	churros, salted bagels, cotton candy, lemonade, or tea.
4	(4) "Mobile Food Facility 4" means a Mobile Food Facility where a Mobile Food Facility
5	Vendor engages in limited food preparation.
6	(5) "Mobile Food Facility 5" means a Mobile Food Facility where a Mobile Food Facility
7	Vendor engages in full food preparation or any food preparation not covered by Mobile Food Facility
8	Categories 1-4, including but not limited to, tacos, burritos, crepes, or falafel.
9	(n) "Mobile Food Facility Vendor" means any person engaged in the business of operating a
10	Mobile Food Facility within the City and County of San Francisco.
11	$(n_{\underline{o}})$ "Owner" or "owners" mean those persons, partnerships, or corporations who are
12	financially interested in the operation of a food preparation and service establishment.
13	$(\Theta p)$ "Operator" means any person engaged in the dispensing of or in assisting in the
14	preparation of food, or a person otherwise employed in a food preparation and service
15	establishment.
16	(pq) "Private school cafeteria" means any food preparation and service facility serving
17	food to faculty and/or students of a school not operated by the San Francisco Unified School
18	District.
19	$(q\underline{r})$ "Restaurant" means any coffee shop, cafeteria, short-order cafe, luncheonette,
20	cocktail lounge, sandwich stand, soda fountain, public school cafeteria or eating
21	establishment, in-plant or employee eating establishment and any other eating establishment,
22	organization, club, including Veterans' Club, boardinghouse, bed and breakfast
23	establishments, or guest house, which gives, sells or offers for sale, food to the public, guests,
24	patrons, or employees as well as kitchens or other food preparation areas in which food is
25	prepared on the premises for serving or consumption on or off the premises, and requires no

1 further preparation and also includes manufacturers of perishable food products that prepare 2 food on the premises for sale directly to the public. The term "restaurant" shall not include 3 *itinerant restaurants* mobile food facilities, cooperative arrangements made by employees who 4 purchase food or beverages for their own consumption and where no employee is assigned 5 full time to care for or operate equipment used in such arrangement, or private homes; nor 6 shall the term "restaurant" include churches, church societies, private clubs or other nonprofit 7 associations of a religious, philanthropic, civic improvement, social, political, or educational 8 nature, which purchase food, food products, or beverages, or which receive donations of food, 9 food products, or beverages for service without charge to their members, or for service or sale 10 at a reasonable charge to their members or to the general public at occasional fundraising 11 events, for consumption on or off the premises at which the food, food products, or beverages 12 are served or sold, if the service or sale of such food, food products or beverages does not 13 constitute a primary purpose or function of the club or association, and if no employee or 14 member is assigned full-time to care for or operate equipment used in such arrangements.

(*r*<u>s</u>) "School food concessions" means any food preparation, food service or food
 products intended for consumption by students attending or participating in activities within a
 school facility.

(*tu*) "Special events" means any organized collection of food purveyors operating
 individually or collaboratively out of approved temporary or mobile food facilities at a fixed
 location for a period of time not to exceed 25 days in a 90-day period in conjunction with a
 single, weekly, or monthly community event as defined in the California Health and Safety
 Code Section 113755.

(#<u>v</u>) "Stadium concession" means any food preparation and/or service facility operating
 within a stadium, arena, or auditorium with a seating capacity of 25,000 or more.

(+W) "Take-out establishment" means any food preparation and service establishment
 which primarily prepares food for consumption off premises.

- 3 (*mx*) "Temporary facility" means any food preparation and service facility operating out
  4 of temporary facilities approved by the Director of Public Health at a fixed location for a period
  5 of time not to exceed 25 days in any 90-day period in conjunction with a single event or
  6 celebration.
- 7 (xy) "Vending machine" means any self-service device, which upon insertion of money
  8 or tokens, dispenses food without the necessity of replenishing the device between each
  9 vending operation.
- Section 5. The San Francisco Business and Tax Regulations Code is hereby amended
   by repealing Section 249, amending Section 249.1, and adding Section 249.23, to read as
   follows:
- 13 SEC. 249. MEAT AND MEAT FOOD PRODUCT VEHICLES.

The license fees prescribed in this Section are due and payable on an annual basis
 each year on April 1. Fees for new licenses issued prior to, or after July 1st, shall be prorated

- 6 (1) Food preparation and service establishments used exclusively by day care facilities
  7 for children are exempt from paying the fees required by this Section.

18 (c) Beginning with fiscal year 2010-2011 and annually thereafter, the fees set forth in this section may be adjusted each year, without further action by the Board of Supervisors, as 19 20 set forth in this subsection. Not later than April 1, the Director shall report to the Controller the 21 revenues generated by the fees for the prior fiscal year and the prior fiscal year's costs of 22 operation, as well as any other information that the Controller determines appropriate to the 23 performance of the duties set forth in this Article. Not later than May 15, the Controller shall 24 determine whether the current fees have produced or are projected to produce revenues 25 sufficient to support the costs of providing the services for which the fee is assessed and that

the fees will not produce revenue that is significantly more than the costs of providing the
services for which the fee is assessed. The Controller shall, if necessary, adjust the fees
upward or downward for the upcoming fiscal year as appropriate to ensure that the program
recovers the costs of operation without producing revenue that is significantly more than such
costs. The adjusted rates shall become operative on July 1.

## SEC. 249.23. MOBILE FOOD FACILITY PLAN CHECK FEE.

7 <u>Each person filing an application for an initial Mobile Food Facility permit under Public</u>

8 *Works Code Section 184.83 also shall pay the Health Department a plan check fee of \$181 per hour.* 

9 <u>This fee is due and payable to the Health Department at the time the applicant requests said plan check</u>

10 *from the Health Department. The fee amount shall be based on the Health Department's estimate of the* 

11 *time required to check the applicant's plans. The Health Department may refund a portion of the fee* 

12 *payment or require additional payment if actual plan check time differs from the initial estimate. The* 

13 *Health Department may withhold plan check approval until payment of the plan check fees and the* 

14 Department of Public Works' Mobile Food Facility permit shall not be final and effective until the

15 *Health Department issue plan check approval. The Controller may adjust this fee annually as set forth* 

16 *in Section 249.1(c).* 

Section 6. This Section is uncodified. (a) Time Limit for Filing Application to Renew 17 18 an Existing Permit—Existing Permit Requirements. All persons who possess an existing valid permit to operate a Mobile Food Facility as defined in this Ordinance heretofore issued by the 19 20 Police Department must file for a new permit with the Department of Public Works within 90 21 days of the effective date of this Ordinance. The application shall include all information 22 related to the most recently issued permit for operation, including the approved Location(s) of 23 service and food product, products, and services offered for sale. Failure so to do shall make 24 continued operation of said place of business a violation of Public Works Code Section 184.97 25 and 184.98 as set forth in this Ordinance. The Director shall reissue new permits to all

persons presently holding existing valid permits to operate Mobile Food Facilities at no cost,
subject to the requirement for annual renewal of the permit from the date the reissuance of the
permit and compliance with the terms and conditions of this Article. Any permit renewal of a
pushcart peddler permit dated as of July 19, 1995 shall include reference to the original permit
granting date.

6 (b) Unless specified otherwise in this Ordinance, any permittee with an existing valid 7 Mobile Food Facility permit issued under Subsection (a) above shall be required to meet all 8 requirements of Public Works Code Article 5.8, including obtaining a Certificate of Sanitation 9 from the Department of Public Health and Fire Marshal approval, on the one year anniversary 10 of the permit issued in accordance with Subsection (a) above. Annual Renewal of said permits shall not require the notice provisions of Section 184.88, unless the permittee is 11 12 changing the Location that the Mobile Food Facility serves, adding a new Location(s), 13 changing the hours of operation to serve a Location later than 12 pm, or making other 14 changes to the Mobile Food Facility that the Director determines requires public notice. 15 Section 7. This Section is uncodified. The Board of Supervisors hereby urges the 16 Department of Public Works to develop an electronic posting of all proposed and existing 17 permit Locations for Mobile Food Facilities within nine (9) months of the effective date of this 18 Ordinance. Such electronic posting shall be available to the public online and at the 19 Department's offices.
