2 Administration - Southern Skyline Boulevard Ridge Trail Extension Project - \$1,000,000]

3 **Resolution authorizing the San Francisco Public Utilities Commission (SFPUC) to**  
4 **accept and expend a grant in the amount of \$1,000,000 from the Metropolitan**  
5 **Transportation Commission, with funds from the Federal Highway Administration and**  
6 **reviewed by the California Department of Transportation for design and construction of**  
7 **the Southern Skyline Boulevard Ridge Trail Extension Project which would extend the**  
8 **Bay Area Ridge Trail south from State Route 92 to the Golden Gate National Recreation**  
9 **Area's Phleger Estate and improve educational and recreational access, parking, and**  
10 **restroom facilities on peninsula watershed land owned and maintained by the SFPUC**  
11 **in San Mateo County, for a term period of May 2022, through January 2024.**

12  
13 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) owns and  
14 manages peninsula watershed land in San Mateo County; and

15 WHEREAS, In 1987, the Bay Area Ridge Trail Council started the Bay Area Ridge Trail  
16 to create an approximately 550-mile long continuous trail for hikers, mountain bicyclists, and  
17 equestrians along the ridgelines overlooking San Francisco Bay; currently, 400 miles of the  
18 Bay Area Ridge Trail have been constructed; the proposed Southern Skyline Boulevard Ridge  
19 Trail Extension (SSBRTE) would complete a new segment of the Bay Area Ridge Trail; and

20 WHEREAS, On December 18, 2002, by Resolution No. 02-0265, the SFPUC adopted  
21 the Peninsula Watershed Management Plan, and adopted a trail proposal that provided multi-  
22 use access (hikers, bicyclists, and equestrians) for the Fifield/Cahill Ridge Trail, and directed  
23 SFPUC staff to seek additional funding opportunities from sources such as grants,  
24 contributions or cooperative funding agreements with governmental agencies, institutions or  
25 other entities interested in jointly funding this project; and

1 WHEREAS, In August 2003, the SFPUC opened the ten-mile Fifield-Cahill Ridge Trail  
2 (FCRT), which extends from the Golden Gate National Recreation Area (GGNRA) Sweeney  
3 Ridge south to State Route (S.R.) 92; and

4 WHEREAS, The proposed Southern Skyline Boulevard Ridge Trail Extension  
5 (SSBRTE) Project would construct the proposed six-mile SSBRTE, creating sixteen-miles in  
6 total of Bay Area Ridge Trail on the peninsula watershed and connected to GGNRA lands on  
7 both ends of the alignment; and

8 WHEREAS, The SSBRTE project consists of two new discrete trail sections: the  
9 Universal Access Loop Trail and the Southern Skyline Boulevard Ridge Trail; the Universal  
10 Access Loop Trail would be a half-mile long interpretive and fully accessible trail segment,  
11 located north of S.R. 92, connected to the existing FCRT, and designed to fully comply with all  
12 applicable standards; the Southern Skyline Boulevard Ridge Trail would be a six-mile long  
13 multi-use (pedestrians, bicycles, equestrian usage) trail, located south of S.R. 92, running  
14 parallel to Skyline Boulevard; and

15 WHEREAS, The Southern Skyline Boulevard Ridge Trail would be located on Skyline  
16 Ridge, on the east side of Highway 35 within the hydrological watershed of the Upper Crystal  
17 Springs Reservoir, and would be a portion of the Bay Area Ridge Trail; and

18 WHEREAS, This project would enhance public access to SFPUC watershed lands,  
19 provide education and recreational opportunities for Bay Area residents while protecting  
20 natural resources and water quality; and

21 WHEREAS, The SFPUC applied for and has been awarded a grant from the  
22 Metropolitan Transportation Commission, using funding from the Federal Highway  
23 Administration (FHWA), and reviewed by the California Department of Transportation  
24 (Caltrans) in the amount of \$1,000,000 for the construction of the SSBRTE project; and  
25

1 WHEREAS, The grant funds require a 3:1 minimum match of funds from the receiving  
2 agency; the required matching funds of \$3,000,000 have already been met through SFPUC  
3 Water Enterprise Capital Improvement Project (CIP) budget; and

4 WHEREAS, The FHWA and SFPUC matching funds will be used for construction of the  
5 six-mile long multi-modal segment of the Bay Area Ridge Trail south of S.R. 92 and west of  
6 the Crystal Springs Reservoir in San Mateo County; and

7 WHEREAS, This grant does not include an Annual Salary Ordinance Amendment; and

8 WHEREAS, In compliance with the California Environmental Quality Act (CEQA), an  
9 environmental impact report (EIR) was written for this project, and the notice of determination  
10 is on file with the Clerk of the Board in File No. 220270; in compliance with the National  
11 Environmental Policy Act, environmental compliance documents are being prepared and will  
12 be provided to the Clerk for inclusion to the file when completed; and

13 WHEREAS, The SFPUC proposes to maximize use of available grant funds on  
14 program expenditures by not including indirect costs in the grant budget; and

15 WHEREAS, The federal grant is being administered by Caltrans, and therefore,  
16 requires the use of Disadvantaged Business Enterprise (DBE) requirements; and

17 WHEREAS, On April 22, 2014, the SFPUC, by Resolution No. 19-0050,  
18 recommended that the Board of Supervisors accept this grant; now, therefore, be it

19 RESOLVED, That the Board of Supervisors authorizes the SFPUC to accept and  
20 expend grant funding in the amount of \$1,000,000 to extend the Bay Area Ridge Trail south  
21 from S.R. 92 to the GGNRA's Phleger Estate and improve the existing Fifield-Cahill ridge trail  
22 to enhance educational and recreational access, parking, and restroom facilities; and

23 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
24 the grant budget; and

1           RESOLVED, That the General Manager of the SFPUC is hereby authorized to execute,  
2 deliver, and perform, in the name of the City and County of San Francisco, all applications,  
3 contracts, agreements, amendments and payment requests necessary to secure the grant  
4 funds and implement and carry out the purposes specified in the applicable grant application;  
5 and, be it

6           FURTHER RESOLVED, That the Board of Supervisors ratifies any administrative  
7 action taken to date with respect to these grants and grant funds.

**MANDATE STATEMENT**

City Administrative Code Section 10.170-1 states that accepting Federal, State, or third-party grant funds in the amount of \$100,000 or more, including any City matching funds required by the grant, is subject to Board of Supervisors approval.

**BACKGROUND**

In 1987, the Golden Gate National Recreation Area, the National Park Service, the Greenbelt Alliance and citizen advocates came together to form the non-profit organization, the Bay Area Ridge Trail Council, with the goal of building the Bay Area Ridge Trail. The Bay Area Ridge Trail is an approximately 550-mile continuous trail for hikers, mountain bicyclists, and equestrians along the ridgelines overlooking the San Francisco Bay. As of April 2022, nearly 400 miles have been constructed.

**Project Timeline**

Creating the Bay Area Ridge Trail has been done incrementally in segments, as public access, especially on the Peninsula Watershed, involves numerous stakeholders and is a controversial issue: the Watershed contains the highest concentration of rare, threatened, and endangered species in the Bay Area. The original concept for the proposed section of Bay Area Ridge Trail called the Skyline Ridge Trail Extension Project, was formalized via PUC resolution (No. 02-0265) in December 2002. The resolution directed staff to seek additional funding opportunities from outside sources to fund the project.

*Grant Award History*

In July 2008, following a competitive grant application process, the PUC was awarded \$185,000 in grant funds from the State Coastal Conservancy for the planning, design, and permitting necessary for construction of the Southern Skyline Blvd Alignment of the Ridge Trail. In October 2008, the Board of Supervisors approved the PUC request to accept and expend the grant funds, along with required local matching funds of \$207,500 from the PUC's FY 2008-09 Water Enterprise Operating Budget (File No. 081280). PUC reports that the total amount of \$392,500 has since been fully expended on project design and permitting.

In December 2013, the PUC was awarded following a competitive application process, a \$1,000,000 Priority Conservation Area Grant from the State Coastal Conservancy for the Southern Skyline Blvd. Ridge Trail Extension Project. In April 2014, the PUC approved a resolution (No. 14-0060) authorizing the project and committing the requisite \$3,000,000 (matching ratio amount of three to one). While the project schedule originally anticipated a trail opening date of December 2016, the PUC reports that there have been significant delays in the permitting process throughout. Nearly a decade after the funds were awarded, today the Board of Supervisors is being asked to consider the proposed project.



**DETAILS OF PROPOSED LEGISLATION**

The proposed resolution would authorize the San Francisco Public Utilities Commission (PUC) to accept and expend \$1,000,000 in grant funding from the Metropolitan Transportation Commission. The funding would support the design and construction of the Southern Skyline Boulevard Ridge Trail Extension Project with the requirement that PUC provide \$3 million in matching funds (matching ratio amount of three to one). The construction term is approximately two years. Following Board of Supervisors approval, the PUC expects construction to commence in early 2023.<sup>1</sup>

**Project Scope**

The purpose of the Southern Skyline Boulevard Ridge Trail Extension Project is to complete construction of an approximately six-mile (31,500 linear feet) trail segment located on land managed and owned by the PUC in the Peninsula Watershed in San Mateo County. The new multi-modal trail segment would supplement the 10-mile Fifiield-Cahill Ridge Trail, forming a new link along the Bay Area Ridge Trail that would provide public access to currently restricted land. This portion of the watershed is currently restricted due to steep terrain and dense vegetation. The project would also provide new trail support facilities and it would construct a half-mile ADA compliant universal access loop adjacent to the Fifiield-Cahill Ridge Trail. See maps in Attachment 1 and Attachment 2 for details. According to PUC staff, a construction contract for the project will be competitively bid. Construction Management services may be provided as well, by a combination of in-house personnel and consultants, based on a future evaluation of qualifications.

**Project Permits and Requirements***Environmental Impact Review (EIR)*

In order to comply with the California Environmental Quality Act (CEQA), the project underwent an Environmental Impact Review (EIR). The EIR process began with a Notice of Preparation in December 2016. A draft EIR was circulated for public comment from June 25-August 10, 2020, and a public hearing was held on July 23, 2020. In response to stakeholder input, the PUC made minor modifications including wildlife friendly barbed-wire fencing and additional educational signage. The revisions to the project did not substantially modify previously proposed project elements. The Planning Commission certified the final EIR on April 29, 2021. In June 2021, PUC filed the Notice of Determination in San Francisco, San Mateo, and at the State Clearinghouse.

<sup>1</sup> The current resolution text should be amended so that the construction term reflects the six-month delay that the PUC has experienced in receiving National Environmental Policy Act (NEPA) approval.

*Disadvantaged Business Enterprises (DBE)*

Because the proposed project would receive federal funding (administered by Caltrans), it must meet DBE program requirements.<sup>2</sup> PUC reports that it will adhere to Caltrans' DBE program and match Caltrans' annual DBE participation goal.

*National Environmental Policy Act (NEPA)*

Because the proposed project is federally funded, the PUC is required to undergo NEPA compliance. NEPA approval is still pending, causing a delay in the previously anticipated May 2022 construction commencement.

**FISCAL IMPACT**

The total project cost is \$25,574,000, which includes \$1 million in Federal Highway Administration Priority Conservation Area grant funds administered by Caltrans as the pass-through agency through the Priority Conservation Area Grant, and \$24,574,000 from the PUC's Water Enterprise Capital Improvement Project budget. The project budget is summarized in Exhibit 1 below. The PUC's contribution to the project far exceeds the \$3 million required by the grant's three to one matching fund stipulations.

According to the PUC grant budget, project trail construction and site work will be split into three sections: North Section, Middle Section and South Section, totaling 31,500 linear feet or approximately \$812 per linear foot. The federal grant funds would be used for the North Section trail construction only. According to PUC, construction costs are high because the trail is being built on a hillside, necessitating extensive retaining walls and a pedestrian bridge. The engineer's

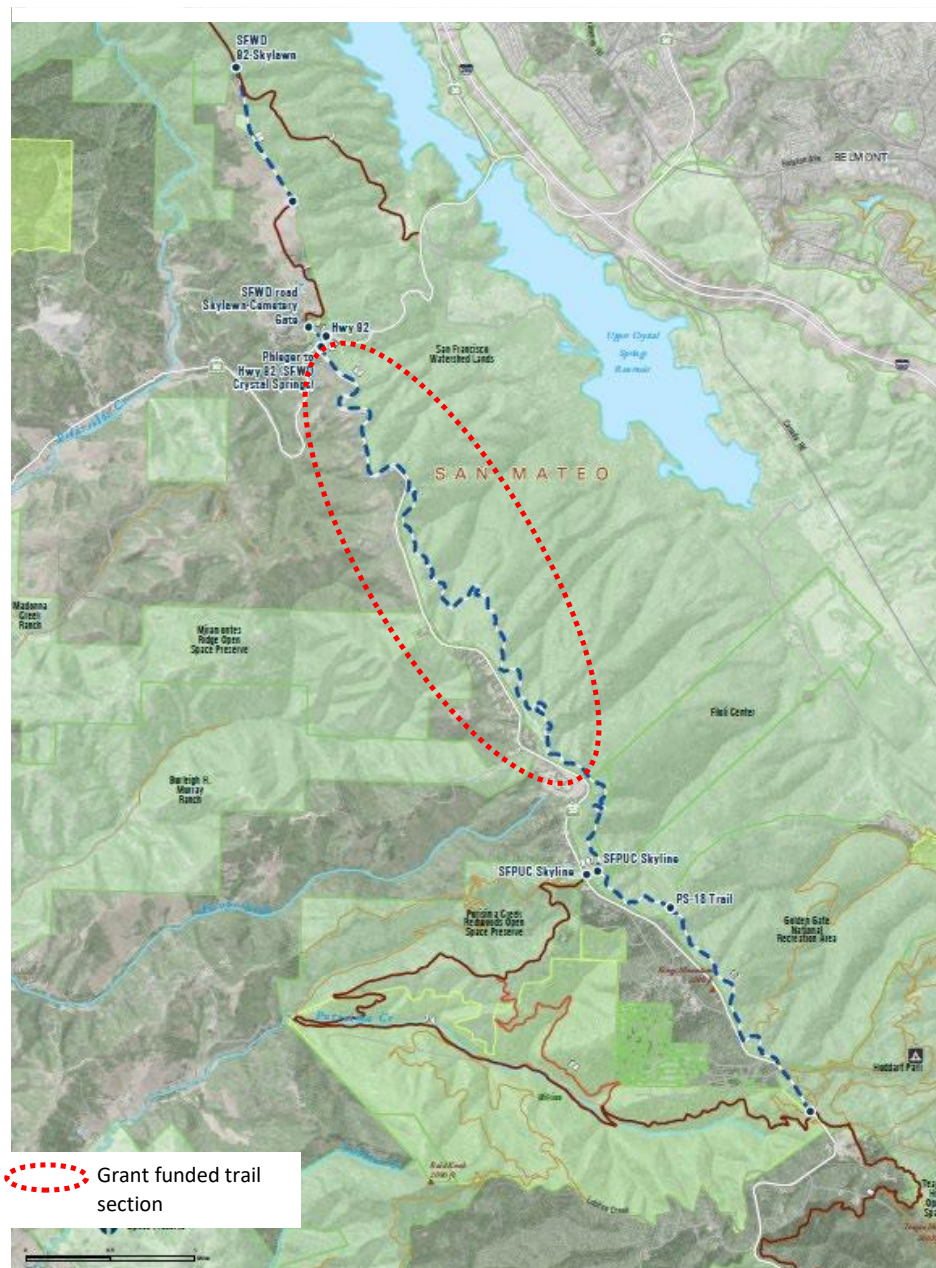

estimate for the project construction costs also includes restrooms, fencing, tree removal, and parking lots.

The Southern Skyline Blvd Ridge Trail will enhance the existing Fifield-Cahill Ridge Trail, and create a new six mile segment of Bay Area Ridge Trail—the Southern Skyline Boulevard Ridge Trail—through the interior of the Peninsula Watershed, property owned and maintained by the SFPUC. The Bay Area Ridge Trail was started in 1987 by the Bay Area Ridge Trail Council to create an approximately 550-mile long continuous trail for hikers, mountain bicyclists, and equestrians along the ridgelines overlooking San Francisco Bay. Currently, 360 miles of the Bay Area Ridge Trail have been constructed.

FHWA grant and SFPUC matching funds will be used for construction of the 6-mile long multi-modal segment of the Bay Area Ridge Trail south of Route 92 and west of the Crystal Springs Reservoir in San Mateo County. Due to steep terrain and dense vegetation, this portion of watershed is currently inaccessible to the public.

In addition to the grant funded segment of the Bay Area Ridge Trail, the SFPUC's project will construct an ADA compliant universal access loop adjacent to an existing section of the Fifield Cahill Ridge Trail which is located north of Route 92.

The goal of the SSB RTE Project is to enhance public access to SFPUC watershed lands, provide recreational opportunities for Bay Area residents, protect natural resources and water quality, and lastly to provide educational opportunities related to the Watershed ecosystem.

## **PROJECT DESCRIPTION**

The purpose of this project is to complete construction of the San Francisco Public Utilities Commission (SFPUC) Southern Skyline Boulevard Ridge Trail Extension (Skyline Trail) on the Peninsula Watershed in San Mateo County, and further planning for the connection south across Golden Gate National Recreation Area (GGNRA) property from this trail to Midpeninsula Regional Open Space District trail network. The 6.0 mile Skyline Trail is a segment of the 550 mile Bay Area Ridge Trail (BART). The trail is located on Skyline Ridge on the east side of Highway 35 within the hydrological watershed of the Upper Crystal Springs Reservoir (see map, attached), which is also known as the Peninsula Watershed, and is owned and managed by the San Francisco Public Utilities Commission. The Skyline Trail project will construct a new multi-modal trail which will provide access to lands currently restricted to public use.

The interior of the Peninsula Watershed was restricted to public access until August 2003 when the SFPUC opened the ten-mile Fifiield-Cahill Ridge Trail (FCRT). The FCRT extends from the GGNRA Sweeney Ridge south to Highway 92.

The need and goal for this project is to connect the existing FCRT with the proposed Skyline Trail which will provide a sixteen-mile segment of Ridge Trail through the interior of the Peninsula Watershed connecting to GGNRA lands on both ends of the alignment. The Skyline Trail will also connect to nearby open space areas managed by the Midpeninsula Regional Open Space District and the San Mateo County Parks Department. Further, if a future trail connector is built in coordination with Caltrans across the Highway 92 corridor, this will expand the trail network immensely.

The Skyline Trail is proposed to be multimodal, available for use during daylight hours, and operated and maintained by the SFPUC.

A portion of the SFPUC budget for the grant includes planning and design of a 1.5 mile segment of the BART on the adjacent GGNRA Phleger Estate. The SFPUC will prepare a schematic trail design and provide an environmental compliance and screening assessment in coordination with the GGNRA. This assessment will help determine the appropriate NEPA pathway for the GGNRA. Both the design and assessment will tier off the 2008 Huddart Park to Highway 92 Ridge Trail Feasibility Study. Coordinating design of the Skyline Trail with the GGNRA as part of this grant proposal will expedite closure of a gap in the BART between SFPUC lands and adjacent public lands.

The SFPUC will have an agreement with the GGNRA to ensure the project meets the needs of both organizations and the California State Coastal Conservancy.

**Explanation of Tasks and Task/Milestones:** See the anticipated schedule on page 9 for “expected completion date”.

**Task 1:** Initiate internal SFPUC CEQA review: Currently SFPUC staff opinion is that the SFPUC can tier off both the Peninsula Watershed Management Plan (PWMP) and the PWMP EIR (State Clearinghouse No. 98082030, certified complete 1-11-201 by Department of City Planning) using a Mitigated Negative Declaration. The Skyline Trail project was analyzed at the programmatic level in the PWMP, but requires additional project level analysis. The City’s CEQA process requires an initial internal review of the proposed project by the SFPUC Bureau of Environmental Management (BEM). BEM makes an initial determination as to the environmental document necessary to complete CEQA. This determination is reviewed and approved by the City’s Department of City Planning. City Planning is the lead agency for the CEQA process. The SFPUC partners with the Department of City Planning to complete and certify the final environmental document (Task/Milestone 4). Task 1 will be undertaken in parallel with Task 2.

**Task 2:** The Conceptual Engineering Report will provide plans and specifications for the project. The CER will summarize the results of geotechnical, environmental, structural, and civil analyses, and design criteria and parameters. The report will include structural plans for 10% design level and civil plans for 50% design level. The report will also include a list of all technical specification sections and any special conditions necessary for the project, other than that covered by SFPUC’s standard specifications. The conceptual CER will be modified per the findings of the CEQA process resulting in the Final Conceptual plans and specifications in Task 3.

**Task 3:** The Final 100% Conceptual plans and Specs will be completed with input from the public process and technical findings of the CEQA process.

**Task/Milestone 4:** CEQA compliance and the certification of the CEQA document will lead to the completion of the Final 100% Plans and specifications Task 5.

**Task 5:** Completion of final plans along with the certified CEQA document will allow Caltrans to verify NEPA compliance in Task/Milestone 6.

**Task/Milestone 6:** Caltrans initiated process to verify NEPA compliance. Completion of this task will allow SFPUC to submit request to Caltrans for FHWA authorization Task/Milestone 7.

The SFPUC is the sponsoring agency and will apply for a Caltrans Master agreement once the grant has been awarded. We have contacted Sylvia Fung, Chief, Office of Local Assistance, and Caltrans-District 4. The SFPUC confirmed that the organization would be submitting a full proposal for a grant amount not to exceed \$1,000,000. We discussed the issues related to the managing FHWA grants through the master agreement process including the required audit and NEPA compliance. We relayed to Caltrans the robust nature of the SFPUC and our ability to qualify and receive a master agreement to manage the grant funds. Chief Fung directed the SFPUC to contact the Office of Local Assistance when the grants are awarded to initiate the Master Agreement application process.

### *2) Your indicated matching funds are all to be secured through your capital planning process. Please describe this process in greater detail and how certain these matching funds are. Matching funds need to be secured by the time the committee makes funding recommendations in late December. The SFPUC is a City and County of San Francisco Department, and is required to annually submit a 10-year capital budget for review and approval to the Commission and the Board of Supervisors. The existing and currently proposed 10-year capital budgets include the required funding for this project. The project funds are in the Watershed and Lands Management Program (CUW 275), and all of the required funding will be in place as part of the annual budget cycle, which is scheduled to be completed with the start of the next fiscal year (FY 14/15) on July 1, 2014.

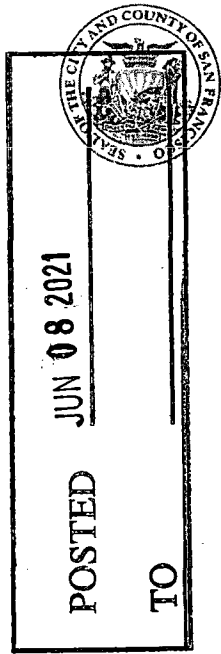

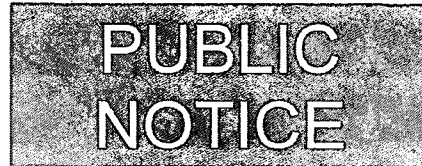

## Project Description

The project sponsor, the San Francisco Public Utilities Commission (SFPUC), proposes to improve and develop recreational trails and associated facilities located within the Peninsula Watershed in central San Mateo County. The Peninsula Watershed property is owned by the City and County of San Francisco and managed by the SFPUC. The project is a component of the SFPUC's Peninsula Watershed Management Plan. The project area includes watershed lands along the Fifiel-Cahill ridge trail, which is approximately 1.5 miles north of the State Route 92 (S.R. 92)/State Route 35 (S.R. 35) intersection (north of the Skylawn Memorial Park), and watershed lands extending south from S.R. 92 approximately 6 miles to the Phleger Estate boundary and east from S.R. 35 a few hundred feet.

Primary project components proposed for areas north of S.R. 92 include a new 0.5-mile universal access loop trail (that would provide Americans with Disabilities Act-compliant access and parking), and a 50-car parking lot and restroom near the watershed's Cemetery Gate, as well as the transfer of a public access easement (from the Bay Area Ridge Trail Council to the SFPUC) along an existing segment of the Bay Area Ridge Trail through Skylawn Memorial Park. Project components proposed for areas south of S.R. 92 include a new 6-mile southern skyline ridge trail along S.R. 35, a 20-car parking lot, and two restrooms. Along the proposed southern skyline ridge trail, the SFPUC would install a prefabricated bridge to span a gulch that intersects the trail alignment.

Under the Project, visitor access would be managed differently for the Fifiel-Cahill and southern skyline ridge trails. Visitors to the Fifiel-Cahill ridge trail would need a reservation and the supervision of a trained volunteer (i.e., docent), similar to current access restrictions. Visitors to the southern skyline ridge trail would need to obtain an access permit, but would not require a reservation or docent. For both trails, access would be provided via designated trailheads and watershed access points. Each of these access points would have a lockable gate, which would remain locked except during the designated access hours.

## Determination

The City and County of San Francisco decided to carry out or approve the above described Southern Skyline Boulevard Ridge Trail Extension project on June 2, 2021 and has made the following determinations regarding the project. Its basic purposes are to: inform governmental decision makers and the public about the potential significant environmental effects of proposed activities; identify ways that environmental damage can be avoided or significantly reduced; require changes in project through the use of alternatives or mitigation measures when feasible; and disclose to the public the reasons why a project was approved if significant environmental effects are involved. CEQA applies to projects undertaken, funded or requiring an issuance of a permit by a public agency.

A **Notice of Determination (NOD)** is a notice filed with the County Clerk's Office following project approval which describes a project and identifies expected environmental impacts, if any. RESOLUTION NO. 14-0060

WHEREAS, The SFPUC considered The Southern Skyline Blvd. Ridge Trail Extension alignment (Alternative A/B: Programmatic Skyline Blvd alignment) at the programmatic level as one of the six access alternatives in the final 2001 SFPUC Peninsula Watershed Management Plan Spring 2002 adopted June 26, 2001(SFPUC Resolution 01-0140); and

WHEREAS, The SFPUC adopted Alternative E as the preferred access alternative for the Fifield-Cahill Ridge trail program; of which the "Skyline Trail" is the southern extension and amended and finalized the Peninsula Watershed Management Plan on December 18, 2002 (SFPUC Resolution 02-0265); and

WHEREAS, The SFPUC; in order to defray costs of the project; directed staff to seek additional funding opportunities from sources such as grants, contributions, or cooperative funding agreements with governmental agencies or other entities interested in jointly funding the Fifield-Cahill Ridge Trail program (SFPUC Resolution 02-0265); and

WHEREAS, The Southern Skyline Blvd Ridge Trail Extension project was recommended by State Coastal Conservancy (SCC), Metropolitan Transportation Commission (MTC) and the Association of Bay Area Government staff for funding in the amount of \$1,000,000 through the Priority Conservation Area Grant Program which supports the "Plan Bay Area " a long-range transportation and land-use/housing plan for the San Francisco Bay Area and the SCC board determined the project would receive Federal Highway Transportation grant funds and the SCC recommended that the project be considered for inclusion in the MTC Transportation Improvement Program; and

WHEREAS, The SFPUC is submitting an application to the MTC for \$1,000,000 in funding assigned to MTC for programming discretion, including but not limited to federal funding administered by the Federal Highway Administration (FHWA) such as Surface Transportation Program (STP) funding, Congestion Mitigation and Air Quality Improvement (CMAQ) funding and/or Transportation Alternatives (TA) funding (herein collectively referred to as REGIONAL DISCRETIONARY FUNDING) for the Southern Skyline Boulevard Ridge Trail Extension (Skyline Trail) Project (herein referred to as PProject) for the Priority Conservation Area Grant Fund Program (herein referred to as PROGRAM); and

WHEREAS, The Moving Ahead for Progress in the 21st Century Act (Public Law 112-141, July 6, 2012) and any extensions or successor legislation for continued funding (collectively, MAP 21) authorize various federal funding programs including, but not limited to the Surface Transportation Program (STP) (23 U.S.C. § 133), the Congestion Mitigation and Air Quality Improvement Program (CMAQ) (23 U.S.C. § 149) and the Transportation Alternatives Program (TA) (23 U.S.C. § 213); and

WHEREAS, State statutes, including California Streets and Highways Code 182.6 and 182.7 provide various funding programs for the programming discretion of the Metropolitan

Planning Organization (MPO) and the Regional Transportation Planning Agency (RTPA); and

WHEREAS, Pursuant to MAP-21, and any regulations promulgated thereunder, eligible project sponsors wishing to receive federal funds for a project shall submit an application first with the appropriate MPO for review and inclusion in the MPO's Transportation Improvement Program (TIP); and

WHEREAS, MTC is the MPO and RTPA for the nine counties of the San Francisco Bay region; and

WHEREAS, MTC has adopted a Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised) that sets out procedures governing the application and use of federal funds; and

WHEREAS, This action does not constitute a "project" under California Environmental Quality Act Guidelines Section 15378 because there would be no physical change in the environment, and environmental review would be completed under CEQA prior to subsequent action by this Commission to approve the project or award of a construction contract to implement the project; and

WHEREAS, The SFPUC is an eligible sponsor for REGIONAL DISCRETIONARY FUNDING; and

WHEREAS, As part of the application for REGIONAL DISCRETIONARY FUNDING, MTC requires a resolution adopted by the responsible implementing agency stating the following:

1. the commitment of any required matching funds; and
2. that the sponsor understands that the REGIONAL DISCRETIONARY FUNDING is fixed at the programmed amount, and therefore any cost increase cannot be expected to be funded with additional REGIONAL DISCRETIONARY FUNDING; and
3. that the project will comply with the procedures, delivery milestones and funding deadlines specified in the Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised); and
4. the assurance of the sponsor to complete the Project as described in the application, subject to environmental clearance, and if approved, as included in MTC's federal Transportation Improvement Program (TIP); and
5. that the project will comply with all project-specific requirements as set forth in the PROGRAM; and
6. that the project (transit only) will comply with MTC Resolution No. 3866, revised, which sets forth the requirements of MTC's Transit Coordination Implementation Plan to more efficiently deliver transit projects in the region; now, therefore, be it

RESOLVED, That the SFPUC is authorized to execute and file an application for funding for the Project for REGIONAL DISCRETIONARY FUNDING under MAP-21 for continued funding; and be it

FURTHER RESOLVED, That the SFPUC by adopting this resolution does hereby state that:

1. The SFPUC will provide any required matching funds subject to completion of necessary environmental review under CEQA and Project approval; and
2. The SFPUC understands that the REGIONAL DISCRETIONARY FUNDING for the Project is fixed at the MTC approved programmed amount, and that any cost increases must be funded by the SFPUC from other funds, and that the SFPUC does not expect any cost increases to be funded with additional REGIONAL DISCRETIONARY FUNDING; and
3. The SFPUC understands the funding deadlines associated with these funds and will comply with the provisions and requirements of the Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised) and the SFPUC has, and will retain the expertise, knowledge and resources necessary to deliver federally-funded transportation projects, and has assigned, and will maintain a single point of contact for all FHWA-funded transportation projects to coordinate within the agency and with the respective Congestion Management Agency (CMA), MTC, Caltrans and FHWA on all communications, inquires or issues that may arise during the federal programming and delivery process for all FHWA-funded transportation projects implemented by the SFPUC; and
4. The Project will be implemented as described in the complete application and in this resolution, subject to necessary environmental clearance under CEQA, Project approval by the SFPUC, and the acquisition of any necessary permits from state and federal resource agencies that are required for Project construction, and, if so approved, for the amount approved by MTC and programmed in the federal TIP; and
5. The SFPUC and the Project will comply with the requirements as set forth in MTC programming guidelines and project selection procedures for the PROGRAM; and
6. The SFPUC (for a transit project only) agrees to comply with the requirements of MTC's Transit Coordination Implementation Plan as set forth in MTC Resolution 3866, revised; and be it

FURTHER RESOLVED, That the SFPUC is an eligible sponsor of REGIONAL DISCRETIONARY FUNDING funded projects; and be it

FURTHER RESOLVED, That the SFPUC is authorized to submit an application for REGIONAL DISCRETIONARY FUNDING for the Project and be it

FURTHER RESOLVED, That there is no legal impediment to the SFPUC making applications for the funds; and be it

FURTHER RESOLVED That there is no pending or threatened litigation that might in any way adversely affect the proposed Project, or the ability of the SFPUC to deliver such Project; and be it

FURTHER RESOLVED, That the SFPUC authorizes its General Manager, or his designee to execute and file an application with MTC for REGIONAL DISCRETIONARY FUNDING for the Project as referenced in this resolution; and be it

FURTHER RESOLVED, That a copy of this resolution will be transmitted to the MTC in

conjunction with the filing of the application; and be it

FURTHER RESOLVED, That the MTC is requested to support the application for the Project described in the resolution and to include the Project, if approved, in MTC's federal TIP; and be it


FURTHER RESOLVED, That the SFPUC hereby authorizes the General Manager to submit on behalf of the City and County of San Francisco, an application to the MTC for \$1,000,000 in grant funding assigned to MTC for programming discretion, for the Southern Skyline Boulevard Ridge Trail Extension Project on the Peninsula Watershed in San Mateo County through the Priority Conservation Area Grant Fund Program, and be it

FURTHER RESOLVED, The SFPUC authorizes the General Manager to commit the required matching funds in the amount of \$3,000,000 and state the SFPUC's assurance to complete the project, subject to necessary environmental review in compliance with the California Environmental Quality Act, Project approval by the SFPUC, and the acquisition of any necessary permits from state and federal resource agencies that are required for Project construction, and be it

FURTHER RESOLVED, that if the MTC grants funds become available, the SFPUC authorizes the General Manager to seek approval of the Board of Supervisors of a resolution authorizing the acceptance and expenditure of the grant funds for Project construction under San Francisco Administrative Code section 10.170, and be it

FURTHER RESOLVED that if MTC grant funds become available, the General Manager is authorized to negotiate and execute any necessary grant agreements with MTC and any other federal or state funding agencies that are required to accept and expend grant funding.
