12 zoned and recommends approval; and

13 WHEREAS, The Police Department has filed zero protests and zero letters of
14 support with the Department of Alcoholic Beverage Control under California Business
15 and Professions Code, Section 24013, and recommends that the Department of
16 Alcoholic Beverage Control issue the liquor license with conditions; and

17 WHEREAS, The Police Department recommends approval with no new
18 conditions; now, therefore, be it

19 RESOLVED, That in accordance with California Business and Professions Code,
20 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
21 hereby determines that the issuance of a Type-42 on-sale beer and wine public
22 premises liquor license to Bin 415 LLC, located at located at 950 Mason Street inside
23 the Fairmont Hotel (District 3), will serve the public convenience or necessity of the City
24 and County of San Francisco; and, be it

2 San Francisco hereby endorses and adopts the recommendation of the Police
3 Department as described above.


