3 **Ordinance authorizing settlement of the lawsuit filed by Fanny Lam against the City**
4 **and County of San Francisco for \$375,000; the lawsuit was filed on April 7, 2020, in San**
5 **Francisco Superior Court, Case No. CGC-20-584065; entitled Fanny Lam v. City and**
6 **County of San Francisco, et al.; the lawsuit involves personal injuries arising from a**
7 **trip and fall accident on O’Farrell Street in San Francisco.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Fanny Lam v. City and County of San
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-20-584065 by the payment
13 of \$375,000. The lawsuit involves personal injuries arising from a trip and fall accident on
14 O’Farrell Street in San Francisco.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 April 7, 2020, and the following parties were named in the lawsuit: Plaintiff Fanny Lam;
17 Defendants City and County of San Francisco, San Francisco Municipal Transit Agency, and
18 Kalin Mann.
