

5 2022, 141 of 193 member states voted to condemn Russia's invasion of Ukraine and  
6 demanded that Russia immediately cease its use of force in Ukraine; and

8 Russian President, Vladimir Putin, Russian elites and their family members, removing  
9 Russian banks from the global SWIFT financial messaging system, and banning United  
10 States imports of Russian oil and natural gas; and

11 WHEREAS, United States Census Bureau data shows that about 14,000 Bay Area  
12 residents were born in Ukraine and about 26,000 claim Ukrainian ancestry. The Bay Area has  
13 a larger number of residents with ties to Ukraine than any other city in California and in the  
14 United States, with 53 residents per 10,000 having a direct ancestral tie to Ukraine and San  
15 Francisco having 62 residents per 10,000 who claim Ukrainian ancestry; and

16 WHEREAS, Ukraine has a Consulate located in San Francisco that is collecting  
17 donations and humanitarian aid for refugees, and helping people sign up to volunteer with  
18 trusted organizations; and

19 WHEREAS, San Francisco's small businesses, organizations and residents have come  
20 together to raise money for Ukrainians with vigils, benefit concerts, marches and fundraising  
21 events being held all across the City; and

22 WHEREAS, San Francisco-based companies are offering assistance to the people of  
23 Ukraine - Airbnb has offered free temporary housing to 100,000 Ukrainian refugees, Google,  
24 Facebook and Twitter have all blocked Russian companies from generating any ad revenue  
25 on their websites; and

1           WHEREAS, Wells Fargo Bank, headquartered in San Francisco, announced a million-  
2 dollar donation to three aid organizations helping in Ukraine - The Red Cross, the United  
3 Services Organizations (USO) and World Central Kitchen; and

4           WHEREAS, Ukrainians in San Francisco have mobilized to raise thousands of dollars  
5 in a grassroots effort to help their community back home, with the most notable local efforts  
6 coming from small business owners like Puskin (San Francisco's only Ukrainian restaurant)  
7 and Hromada SF a local non-profit serving the Ukrainian community; and

8           WHEREAS, San Francisco Mayor London Breed issued a letter to the San Francisco  
9 Retirement Board asking the Board to divest from financial and investment ties to Russia and  
10 the Russian government; and

11           WHEREAS, California Governor Gavin Newsom signed an Executive Order ordering  
12 State agencies to ensure that all their contractors comply with economic sanctions imposed  
13 on Russia in response to Russia's attacks on Ukraine; and

14           WHEREAS, State Senate Majority Leader Mike McGuire has announced plans to  
15 introduce legislation that would require the California Public Employees' Retirement System  
16 and California State Teachers' Retirement System to divest from Russian investments; and

17           WHEREAS, Major cities and states across the nation with the highest populations of  
18 Ukrainian immigrants (New York, Pennsylvania, New Jersey, Illinois, California) are standing  
19 in solidarity through a range of legislative efforts; and

24 Governor Kathy Hochul announced that the state stands ready to welcome Ukrainian  
25 refugees, while also pushing state agencies to curb business with Russian entities; and

13 but not limited to the 1989 Sanctuary Ordinance and the 2013 Due Process for All Ordinance.  
14 In 2017, then Mayor Ed Lee re-affirmed San Francisco's sanctuary city policy; now, therefore  
15 be it

17 Ukraine into our community and urges our state and federal leaders to act immediately and  
18 with determination to rightfully bring at-risk and vulnerable Ukrainian peoples and their  
19 families to the United States; specifically, the Board of Supervisors encourages California to  
20 accept more and house more Ukrainian refugees and supports access to significant  
21 opportunities and benefits to individuals and families arriving from Ukraine; and be it

22           FURTHER RESOLVED, The Board of Supervisors calls upon our residents, community  
23 leaders, businesses, faith-based organizations, and community-based organizations to  
24 welcome these Ukrainian families in offering benefits and services to Ukrainian refugees  
25

1 including, but not limited to, housing, food, legal representation, and familial reunification  
2 efforts; and be it

3 FURTHER RESOLVED, That the City and County of San Francisco hereby urges  
4 President Joe Biden and the federal government to work speedily to resolve visa  
5 requirements, and to establish a mechanism to quickly and efficiently accept refugees from  
6 the Ukraine; and be it

7 FURTHER RESOLVED, That this Resolution be forwarded to the Offices of President  
8 Joe Biden, California Governor Gavin Newsom, Speaker of the House Nancy Pelosi, and  
9 Senate Majority Leader Chuck Schumer.
