Carla,

I can appreciate how hard your job is. To reform and restore credibility to the Department of Public Works is a massive undertaking in cultural and process change. To that end, I would like to offer my support to you.

A quick story if I may, I was in the Department of Building inspection a while ago and happened to be on the elevator up to the fourth floor. On the elevator I noticed 3 Asian gentlemen holding big thick notebooks that were clearly labeled "Engineering". I asked one of the gentlemen, if I could ask him a question. I then asked him, "How come the DBI doesn't require engineering plans anymore for new home construction permits, as I was required to have them when I did my project?" His answer, "I don't have to talk to you." The other two gentlemen, both DBI employees, just looked down and did not say anything. I followed him, and inquired who this gentlemen was. After explaining what happened to a secretary, she apologized and showed me employee pictures. It was Tom Hui. Obviously no adverse consequences occurred despite my complaint to his supervisor, and he was subsequently promoted to lead the DBI. The next time I saw this Mr. Hui's picture it was in the 3/11/20 Examiner article, <u>"Mayor Breed seeking dismissal of top building official amid corruption investigation".</u>

Point being, that when public servants become the criminals, the tax payers become the enemy, the patsy the marks. When the head of the agency as large as the DBI or DPW becomes the criminal ,which as you know, was the case here in SF. A city, where outside forces, the FBI and U.S Attorney, had to brought in, because our cities own internal checks and balances failed our tax paying citizens. In this situation the taxpayers constituents are left as bag holders, dealing not dealing with civil servants but with a kid of organized mafia, who at each level, the public has to interact with a different personal profit center motive. The situation you inherited meets the classic definition of a control fraud, where the company or in this case the organization is run for the benefit of the managers. Within this toxic mix are

some really fine people like the secretary at the DBI. Your challenge is to determine your team.

I am writing this note to you for 3 reasons. (1) Because I did not receive any response from Deputy Director Albert Ko. (2) I do not expect Mr. Ko to respond. (3) I have a dispute with the DPW regarding the repair work at my property which I am trying to resolve but which I keep on running into the same pattern of behavior that I experienced from Tom Hui @ DBI.

A quick outline of just the undisputed facts in my case and the current situation in regards to the sidewalk in front of my house.

1) The work performed by DPW's contractor at Empire Engineering & Construction, notice to repair # 1145953, at my property address **<u>did and would not pass City Standards</u>**, and left a trip hazard which did not exist prior to the commencement of Empire's work.

2) The above work was certified as completed despite the defects, and the damage to the surrounding sidewalk by Nick Hasse who as I understand is still employed as an inspector in your department.

3) Inspector Nick Hasse's direct supervisor Woojoo Chung, after receiving photo documentation of the above via email, came to my property and met with me and my neighbor David Ching. Mr. Chung offered me 2 options. Mr. Chung, said he consulted with his supervisor Michael Lennon before his visit and was authorized to offer me a 50% reduction of the charge, if I would drop my complaint and accept the damage and trip hazard. Or I could pay the full amount and he could make the contractor fix the trip hazard and replace the surrounding squares that were cracked by Empire.

4) As his actions demonstrate, Mr. Chung, nor his supervisor Michael Lennon were not concerned with the trip hazard on the sidewalk which purportedly is the "safety purpose" of sidewalk repair program. (A condition that still exists.)

5)Yesterday, I spoke to Mr. Chung about my options and the upcoming Board of Supervisors hearing in which I will be allotted only 2 minutes per rules to state my objections to a \$432 plus 12% lien on my property. He informed me that my only option was to accept the 50% reduction on the charge and litigate collateral damages with Empire on my own. Mr. Chung then went on to explain, that is why the DPW uses subcontractors so that transfer the liability for damage to subcontractors.

6) Mr. Chung is in possession of a signed statement dated 11/18/19 from my neighbor David Ching (415) 386 5536 which states that he witnessed me patching the sidewalk and the date of that repair. (A repair that took less than 4 oz of concrete mix.) Mr Chung was also told the same by Mr. Ching during his site visit.

Several open questions still remain: Is this the pattern of behavior which we can expect under your leadership going forward, or are these legacy attitudes, or bad apples left over from the admitted felon that ran the department prior to your tenor? Who is the villain? What is the trust relationship? How was the trust relationship betrayed?

I did not accept the offer of 50% reduction of my charge, as I don't want to be the bag holder for future claims. No prudent person would do so.

My request is simple. I am writing to request a re-inspection of the sidewalk repair in front of my property and a written re-certification that the repair job performed by Empire passes city standards before a lien is placed on my residence. I would be pleased he hear your thoughts on

the matter.

Thank you for your reply. Do you have any other photos of the completed repair work beside the one below? Prior to my meeting with Woojoo, I believe he had photos of the repair work shot taken from east to the west instead of west toward east orientation. I also handed him hard copies of the photos when he met with myself and Mr. Ching, which should be included in his inspection notes. If you have not had the opportunity to view those photos, I believe that Teresa McNamara also has them.

These photos clearly show the trip hazard, on the far right square that Woojoo saw during his inspection. Conveniently it is missing in the below photo taken by Nick Haase. If you would like me to send you another photo from that angle - that shows the trip hazard. I would be happy to do so.

I guess the question comes down to, would the repair work done by DPW pass "per City Standards" really pass? A photo from a different angle would show clear and convincing evidence that it would not. I would be happy to send you such a photo. The current condition is still there easy to see.

Good afternoon, Fred,

Yes, I am confident the work completed by the SIRP contractor complied with applicable standards, and support Mr. Haase's approval. I also reviewed the history involving your property and verified that (1) repairs were required, (2) patching or other temporary methods of repair were not completed prior to the time the SIRP Contractor was present and beginning to undertake repairs, and (3) Public Works had not received any communications from you indicating that you were going to complete the requisite repairs on your own. As such, the work was completed by the SIRP Contractor, after which you engaged with Mr. Haase and Mr. Chung.

I have included a series of photos below depicting the sidewalk areas in question at the time of initial inspection on November 5, 2018, at the time of second inspection on July 23, 2019, and post-construction on December 23, 2019. As you can see, the voids in the sidewalk marked for repair at the time of initial inspection had not been abated prior to the time of second inspection and, therefore, were included in the work package for the SIRP Contractor.







In addition, there is language included in the Notices to Repair issued to property owners concerning their responsibilities related to undertaking repairs and communicating with the City. Specifically, the second page of the Notice to Repair provides:

"Obtaining permits for sidewalk repairs or for other purposes does not release the property owner from the obligation of completing the ordered work by this notice in the time specified. If additional time beyond the expiration of this notice is required to complete the ordered work, the property owner is responsible for contacting the inspector issuing this notice. Failure to do so may result in the ordered work being performed by the City at the property owner's expense.

Once the City-authorized contractor arrives at the location indicated on this notice, the work will be prosecuted to completion. The property owner will be billed for all costs associated with construction, processing, and verification, including any costs incurred through interference or delay."

Based on the foregoing, Public Works will be seeking to collect on the costs of repairs. However, as I believe Mr. Chung had previously offered, we would be willing to offer a 50% discount in order to resolve this matter.

Please let me know if you're interested in the 50% discount and, if so, we'll issue a revised invoice. If not, we will proceed to hearing with the invoice/property included.
