13	amended, and related Federal Regulations, the City and County of San Francisco is eligible to	
14	apply for and receive a Community Development Block Grant (CDBG); and	
15	WHEREAS, The City and County of San Francisco anticipates receiving approximately	
16	\$18,232,150 in FY2022-2023 CDBG Program funds from the U.S. Department of Housing and	
17	Urban Development (HUD) and has approximately \$5,970,000 in anticipated Program Income	
18	and reprogrammed funds, for a combined total of approximately \$24,202,150; and	
19	WHEREAS, The Citizen's Committee on Community Development (CCCD) has	
20	prepared recommendations for FY2022-2023 CDBG funding as set forth in a proposed	
21	Expenditure Schedule, a copy of which is located in Clerk of the Board of Supervisors File	
22	No. 220458; and	
23	WHEREAS, The proposed grant does not require an Annual Salary Ordinance	
24	amendment; and

1	WHEREAS, The funding agency (HUD) does not allow use of grant on indirect costs
2	now, therefore, be it

RESOLVED, That the Mayor of the City and County of San Francisco is hereby authorized to apply for, accept, and expend the City's 2022 CDBG Program funds from HUD and expend an estimated \$5,970,000 in Program Income and reprogrammed funds, all in accordance with the purposes and goals for the funding as generally set forth in 2020-24 Five Year Consolidated Plan and the Expenditure Schedule; and, be it

FURTHER RESOLVED, That the Board of Supervisors does hereby approve the purposes and goals for FY2022-2023 CDBG Program funding as set forth in the Expenditure Schedule for recipient agencies and departments; and, be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and, be it

FURTHER RESOLVED, That the Mayor is hereby authorized to enter into and execute agreements between the City and County of San Francisco and various agencies consistent with FY2022-2023 CDBG Program and the Expenditure Schedule; and, be it

FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation and certifications as may be requested or required by HUD, and to take such additional actions as may be required to apply for, accept and expend the FY2022-2023 CDBG funds consistent with this Resolution and the goals of the FY2022-2023 CDBG Program and all applicable legal requirements, and any such actions are solely intended to further the purposes of this Resolution, and are subject in all respect to the terms of this Resolution, and any such action cannot increase the risk to the City, or require the City to expend any resources, and that the Mayor shall consult with the City Attorney prior to execution and provided that within 30 days of the agreements approved by this Resolution being executed by all parties, such final documents (showing marked changes, if any) shall be provided to the

1	Clerk of the Board, for inclusion in the official file, together with a brief explanation of any
2	actions from the date of the adoption of this Resolution; and, be it
3	FURTHER RESOLVED, That all actions heretofore taken by the officers of the City
4	with respect to the application for, or the acceptance or expenditure of, FY2022-2023 CDBG
5	funds and Program Income, as consistent with the documents herein and this Resolution, are
6	hereby approved, confirmed and ratified.
