7 WHEREAS, Dr. Ruth Marie Jackson was a loving mother, grandmother, sister, aunt,  
8 cousin, friend, and community leader in Sunnydale and the larger Visitacion Valley  
9 neighborhood for more than five decades; and

10 WHEREAS, Dr. Ruth Marie Jackson owned and operated a licensed home daycare  
11 offering childcare and play experiences for more than four decades; and

12 WHEREAS, Dr. Ruth Marie Jackson was an education specialist with the San  
13 Francisco Unified School District for over 22 years serving the people of San Francisco; and

14 WHEREAS, The annual, daylong celebration began in 1998 when then Mayor Willie  
15 Brown dedicated Ruth Jackson Family Day in honor of the longtime educator and Visitacion  
16 Valley community leader; and

17 WHEREAS, Dr. Ruth Marie Jackson received her Honorary Doctorate in Humanities  
18 from Sacramento Theological Seminary & Bible College on June 29, 2019; and

19 WHEREAS, Dr. Ruth Marie Jackson established the parade and fair, to bring local  
20 families together and break the invisible barriers dividing the community; and

21 WHEREAS, Visitacion Valley, located in the far southeastern portion of San Francisco,  
22 is both isolated and racked by poverty; and

23 WHEREAS, The Sunnydale neighborhood, which was originally built as temporary  
24 housing for returning soldiers after World War II, is the largest public housing project in the  
25 city; and

1           WHEREAS, Dr. Ruth Marie Jackson was honored by Mayor London N. Breed in 2019  
2 for her lifelong commitment to public service; and

3           WHEREAS, Dr. Ruth Marie Jackson left this world suddenly on November 7, 2021, at  
4 the age of 77; and

5           WHEREAS, Dr. Ruth Marie Jackson always said, "If I got it, then it makes no sense to  
6 keep it, if somebody is in need. Giving is what we're supposed to do"; now, therefore, be it

7           RESOLVED, That pursuant to its authority under California Government Code, Section  
8 34091.1 and California Streets and Highways Code, Sections 970.5 and 5026, the Board of  
9 Supervisors hereby renames Hanh Street, between Sunnydale Avenue and Visitacion  
10 Avenue, to "Mrs. Jackson Way" to honor Mrs. Jackson's legacy, and to make clear that the  
11 City and County of San Francisco stands with its Black and Pacific Islander communities  
12 during this extraordinarily difficult time for those communities; and, be it

13           FURTHER RESOLVED, That the Board of Supervisors directs the Municipal  
14 Transportation Agency to erect street signs in accordance with Transportation Code, Section  
15 2.2, which signs should indicate both the new and the former names of the street affected by  
16 this Resolution—the new street name, "Mrs. Jackson Way," in large letters and the former  
17 name, "Hahn Street," in smaller letters above or beneath the new name—and such signs  
18 indicating the two street names shall remain posted for five years and then replaced with  
19 signs indicating only the new street name "Mrs. Jackson Way"; and, be it

20           FURTHER RESOLVED, That in adopting this legislation, the Board of Supervisors  
21 does not intend to effectuate any change in City department jurisdictional control over the  
22 public right-of-way to be renamed as "Mrs. Jackson Way"; and, be it

23           FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board  
24 to promptly forward a copy of this Resolution to the County Surveyor in accordance with  
25

1 California Streets and Highways Code, Section 5026, and that the County Surveyor include  
2 the new street name on the Official Map of the City; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors directs the Department of  
4 Public Works to add “Mrs. Jackson Way” to the City’s official list of street names.

The letters provided the fronting property owners the opportunity to submit their comments concerning the street name change until April 14, 2022. Out of the 20 fronting property owners 7 were against and 1 were in favor of the name change.

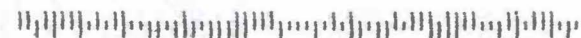

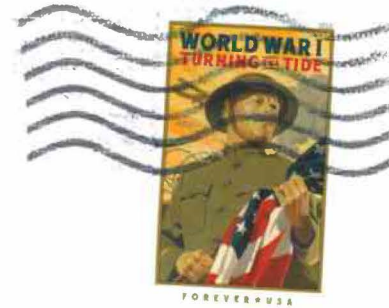


