13 14	Be it ordained by the People of the City and County of San Francisco:		
15	Section 1. The Administrative Code is hereby amended by adding Chapter 96F,		
16	consisting of Sections 96F.1 and 96F.2, to read as follows:		
17	CHAPTER 96F: COMMUNITY POLICING PLANS		
18	SEC. 96F.1. COMMUNITY POLICING PLANS; FOOT AND BIKE PATROLS.		
19	(a) Creation of District Station Community Policing Plans. The Police Department		
20	("SFPD") shall continue to create a Community Policing Plan ("CPP") for each police district		
21	station that shall be publicly available and posted on SFPD's website and on each station's website.		
22	(b) Community Policing Plans. The Police Department shall finalize the CPPs no later		
23	than January 1, 2023, and review and update them on an annual basis by January 1 of each year. The		
24	purpose of CPPs are to foster collaboration and open communication between police officers and		
25			

1	community members, including neighborhood associations and groups, small businesses, merchant
2	groups, non-profits, school groups, and neighborhood leaders. The CPPs shall:
3	(1) Support a culture and practice of policing that reflects the values of protection and
4	promotion of the dignity of all people, and, especially, the most vulnerable in the community.
5	(2) Foster an environment where requests for service and information from SFPD are
6	handled in a timely and transparent manner.
7	(3) Support community engagement and positive interactions and relationships
8	between SFPD and the community. Support the Police Department's ongoing reform efforts to
9	increase community engagement, trust, positive interactions, and relations between the
10	community and police officers.
11	(4) Promote collaboration with groups as described in this section (b), above, to identify
12	problems as well as solutions that will produce meaningful results for the community, and incorporate
13	information learned from the Community Process in subsection (d).
14	(5) Subject to the budgetary and fiscal provisions of the Charter and staffing
15	availability. Deleploy foot and bike patrol officers, as specified in subsection (c), at each district
16	station.
17	(6) Include a succession plan for the transfer and continual implementation of
18	CPPs when changes in district station captains occur.
19	(c) Community Policing Strategies. The Police Department shall provide time and
20	resources for departmental involvement in community events, relationship-building exercises
21	and problem-solving activities. The Police Department shall serve the diverse populations
22	represented in the district station using the principles of the CPPs.
23	SFPD shall create community policing strategies that address deployment of foot and bike
24	patrols, quality of life issues, and community language access needs as follows:

25

1	(1) Foot and Bike Patrols. Police Officers working outside the confines of a patrol
2	car may find it easier to interact with community members and to identify otherwise
3	overlooked problems. SFPD shall (A) adopt a foot and bike patrol strategy that will deploy foot and
4	bike patrol officers at every district station to effectively reduce crime and strengthen the SFPD's
5	partnership and trust with the community, and (B) develop a formula for designating the foot and bike
6	patrol streets and boundaries based on the reporting of crime, high volume foot traffic, crime
7	prevention, and community input. The Police Department shall continue to evaluate the
8	effectiveness of this deployment and readjust the strategy by considering the numbers of calls
9	for service, crime prevention initiatives, and individual interactions with the community.
10	(2) Quality of Life Issues. SFPD shall develop a strategy for proactive problem solving
11	on quality of life issues, nuisances, and crime prevention, and identify alternatives to criminal law
12	enforcement for quality of life issues. In the face of these concerns, SFPD community policing
13	strategies shall create a sense of community where members of the community feel safe and secure.
14	(3) Language Access Needs. SFPD shall incorporate a strategy tailored to address the
15	distinct language access needs of communities served by each district station.
16	(d) Community Process. SFPD shall create a public process for eliciting community input
17	for the CPPs from community members, including neighborhood associations and groups, small
18	businesses, merchant groups, non-profits, school groups, and neighborhood leaders that provide direct
19	services to San Francisco residents in their respective district stations before adoption of the CPPs.
20	SFPD shall consider and incorporate, to the extent possible, community feedback that includes a pro-
21	active problem-solving approach in designing CPPs. This public process is intended to allow the
22	community to provide valuable input to SFPD as a measure of accountability.
23	SEC. 96F.2. UNDERTAKING FOR THE GENERAL WELFARE.
24	In enacting and implementing this Chapter 96F, the City is assuming an undertaking only to
25	promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an

1	obligation for breach of which it is liable in money damages to any person who claims that such breach			
2	proximately caused injury.			
3	Section 2. Effective Date. This ordinance shall become effective 30 days after			
4	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the			
5	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board			
6	of Supervisors overrides the Mayor's veto of the ordinance.

REVISED LEGISLATIVE DIGEST

(5/12/2022, Amended in Committee)

[Administrative Code - Community Policing Plans and Foot and Bike Patrols]

Ordinance amending the Administrative Code to require the Police Department to create a Community Policing Plan ("CPP") at each district police station, that, among other strategies, incorporates a foot and bike patrol deployment, and also includes a community process for eliciting input; and to require the public posting of the CPPs with a yearly update.

Existing Law

Currently, there is no local ordinance that requires the Police Department to create CCPs for each district station.

Amendments to Current Law

This ordinance would require the Police Department to create CCPs for each district station that, among other strategies, incorporates a foot and bike patrol deployment, and also includes a community process. This ordinance would require SFPD to publicly post CCPs and update them annually.

Committee Amendments

On May 20, 2022, Public Safety and Neighborhood Services Committee amended the ordinance to clarify that the deployment of foot and bike patrol officers is subject to the City's budget process and staffing availability.

Background Information

As part of the United States Department of Justice Reform Recommendations, SFPD developed a Community Policing Strategic Plan in 2018 that is publicly available at https://www.sanfranciscopolice.org/your-sfpd/policies/community-policing-strategic-plan.

Dear Ms. Calvillo,

On April 11, 2022 the Small Business Commission (the Commission) heard BOS File #220240 – Community Policing Plans - Foot/Bike Patrols. Alan Wong, Legislative Aide to Supervisor Mar, presented the legislation. Mr. Wong reviewed the proposal and emphasized that this would initiate a process to get community input on local policing strategies, with a particular emphasis on ensuring that community can provide input and communicate with local police officers in languages other than English.

After thorough discussion, the SBC unanimously voted (4-0 with two absences) to support this legislation.

The Commission understands the importance of public safety on neighborhood commercial corridors; public safety is a common concern among the small business community. This legislation lays out a process for police to work with community members to identify policing strategies that are tailored to the local neighborhood needs.

Commissioners raised questions regarding implementation and follow-through of the community policing plans, including how staffing needs would be addressed, if appropriate. They also emphasized the need for continuity in relationships between the community and each district Police Captain, and see the community policing plans as a way to improve continuity when Police Captains rotate out of a station. Overall, the Commission finds the legislation helpful to ensuring each district police station develops a community-based plan to address public safety that is rooted in the specific needs of each neighborhood.
