Be it ordained by the People of the City and County of San Francisco:

Section 1. Chapter 20 of the Administrative Code is hereby amended by revising Article XII, Section 20.310, to read as follows:

SEC. 20.310. SUNSET.

Unless extended by ordinance, this Article XII shall expire by operation of law, and the Committee shall terminate, on July 1,—2022 2027. After the expiration of the Committee, the City Attorney shall cause this Article to be removed from the Administrative Code.

Section 2. Effective Date: Retroactivity.

(a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.

(b) If the effective date of this ordinance is after July 1, 2022, the ordinance shall be retroactive to July 1, 2022, with the intended result that the Shelter Monitoring Committee may continue its operations uninterrupted.
