14 Section 1. The Board of Supervisors hereby adopts and implements the Collective
15 Bargaining Agreement between the City and County of San Francisco and the International
16 Brotherhood of Electrical Workers, Local 6, ("CBA") to be effective July 1, 2022 through June
17 30, 2024.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the CBA.
