14 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum
15 of Understanding (“MOU”) between the City and County of San Francisco and Operating
16 Engineers Local Union No. 3 Supervising Probation Officers, to be effective July 1, 2022
17 through June 30, 2024.

18 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board
19 File No. 220578.

20 Section 2. The Board of Supervisors hereby authorizes the Department of Human
21 Resources to make non-substantive ministerial or administrative corrections to the MOU.

22 Section 3. This ordinance shall become effective upon enactment. Enactment occurs
23 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
