15 Section 1. The Board of Supervisors hereby adopts and implements the Third  
16 Amendment to the 2018-2023 Memorandum of Understanding (“MOU”) between the City and  
17 County of San Francisco and the San Francisco Fire Fighters Union, Local 798, Unit 1, to  
18 restore effective June 30, 2022, a deferred two percent (2%) base wage increase originally  
19 due on July 1, 2020.

20 The Third Amendment so implemented is on file with the Clerk of the Board of  
21 Supervisors in Board File No. 220593.

22 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
23 Resources to make non-substantive ministerial or administrative corrections to the MOU.

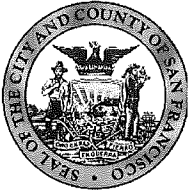


