Describing and setting forth a proposal to the voters at an election to be held on November 3 8, 2022, to amend the Charter of the City and County of San Francisco to provide for the 4 forfeiture of City-funded pension benefits of a member of the San Francisco Employees' 5 Retirement System upon a finding by clear and convincing evidence after an administrative 6 hearing that the member committed bribery, embezzlement, extortion, or wire fraud in 7 connection with the member's duties as a City employee or officer, or committed perjury in 8 connection with or to conceal any such crime; and providing all time and service beginning 9 with the date when the member first engaged in the specified criminal conduct or perjury 10 through the date of the adverse administrative decision shall be excluded from the 11 computation of the service to be credited to the member for the purpose of determining 12 whether such member qualifies for retirement and calculating benefits. 13 14 Section 1. The Board of Supervisors hereby submits to the qualified voters of the City 15 and County, at an election to be held on November 8, 2022, a proposal to amend the Charter of 16

15	(a) Any application for retirement or death allowance made pursuant to this Charter, or
16	any pension forfeiture administrative proceeding initiated pursuant to this Charter, shall be
17	heard by a hearing officer employed under contract by the Retirement Board and selected by
18	procedures set forth in its rules, which shall include rules setting forth the qualifications and
19	selection procedure necessary to appoint a qualified and unbiased hearing officer.
20	(b) Application for retirement or death allowance.
21	(1) Following public hearing, the hearing officer shall determine whether such
22	application shall be granted or denied. All expenses related to processing and adjudicating such
23	applications shall be paid from the Trust Fund.

1	(2) At any time within 30 days after the service of the hearing officer's decision,
2	the applicant or any other affected party, including the Retirement System, may petition the
3	hearing officer for a rehearing upon one or more of the following grounds and no other:

5	powers;
6	$\frac{2}{(B)}$ That the decision was procured by fraud;
7	3.(C) That the evidence does not justify the decision; or

9	with reasonable diligence, have been discovered and produced at the hearing.
10	(3) The decision of the hearing officer shall be final upon the expiration of 30
11	days after the petition for rehearing is denied, or if the hearing is granted, upon the expiration of
12	30 days after the rendition of the decision. Such final decision shall not be subject to amendment,
13	modification or rescission by the Board, but shall be subject to review by the Board only for the
14	purpose of determining whether to seek judicial review.
15	(c) Pension forfeiture administrative proceeding. Following an administrative hearing,
16	the hearing officer shall determine whether the Retirement System has met its burden of proving
17	by clear and convincing evidence that the member has committed bribery, embezzlement,
18	extortion, or wire fraud in connection with the member's duties as an officer or employee of the
19	City and County, or committed perjury in connection with or to conceal any such crime, and
20	shall issue a written decision setting forth the hearing officer's factual findings and legal
21	conclusions. The hearing officer's decision shall be a final administrative decision. The
22	member may appeal an adverse decision by filing in San Francisco Superior Court a petition for
23	<u>a writ of mandate under California Code of Civil Procedure, Section 1094.5 et seq., as</u>
24	applicable, and as may be amended from time to time. If the court reverses the forfeiture
25	decision and finds in favor of the member, the member's pension benefits shall be reinstated.
