The Board of Supervisors acknowledges the findings made by the Planning Department, by its letter dated March 19, 2021, and revised findings dated April 7, 2021, that the proposed subdivision, on balance, is consistent with the objectives and policies of the General Plan, and the eight priority policies of Section 101.1 of the Planning Code; and WHEREAS, A copy of the Planning Department letter is on file with the Clerk of the

Board of Supervisors and incorporated herein by reference; and

WHEREAS, Because the Subdivider has not completed the required public improvements associated with this Final Map and certain conditions have not been fulfilled at the time of the filing of this Final Map, the Subdivision Code requires that the Subdivider and City enter into a Public Improvement Agreement to address these requirements; and
