Dear Supervisors,

I am writing on behalf of RepresentUs to express our enthusiastic support for the proposed charter amendment to move San Francisco’s municipal elections to even-numbered years and readjust the signature threshold for voter initiatives (File No. 220638). RepresentUs is a nonpartisan election reform organization that seeks to dismantle the root causes of inequality in our democracy and end political corruption, extremism, and gridlock. RepresentUs is involved in efforts around the country to defend the integrity of the democratic process.

Consolidating local elections with even-year elections is a proven and commonsense way to improve turnout and save money. The evidence is overwhelming that holding municipal elections leads to significantly higher voter turnout.¹ Cities across California have experienced drastic increases in voter turnout after switching to even-year elections, and San Francisco *already* has much higher voter turnout for state and federal elections held on even years than it does in local elections.² In addition to turnout increases, consolidating elections makes financial sense. Research shows that cities using odd-year municipal elections spend significantly more per voter on elections than cities that consolidate local races with even-year elections.³

Voter participation is a complex issue that involves many different factors. It is rare to find a single change that directly and unambiguously creates an immediate and significant improvement in voter turnout. It is almost impossible to find a single change that causes such drastic increases in turnout while simultaneously saving money. Consolidating local elections to even years is essentially a public policy unicorn.

Our democracy faces grave challenges as efforts to roll back ballot access and undermine voting rights are rising across the country. San Francisco has the opportunity to be a national

Dear Members of the San Francisco Board of Supervisors:

On behalf of California Common Cause, we are proud to support the proposed charter amendment to be submitted to the voters that would amend the Charter of the City and County of San Francisco to change the election cycle for the offices of Mayor, Sheriff, District Attorney, City Attorney and Treasurer so that these offices will be elected in even-numbered years. Please accept this letter to reflect our support of the measure.

In 2015 California Common Cause was the lead supporter of SB 415, the California Voter Participation Rights Act which sought to remedy the persistent problem of low voter turnout in critically important local elections, which often happened on off-cycle dates.¹ SB 415 added a mandate to the elections code that cities consolidate local elections with state and federal elections if those off-cycle elections resulted in turnout that was 25 percent or more lower than voter turnout for the previous four statewide general elections.²

In support of SB 415, California Common Cause cited a Public Policy Institute of California (PPIC) survey of 350 California cities that found that simply moving an election to be synchronized with the even-year state elections can result in a 21-36 percent boost in voter turnout for municipal and other local elections.³ However, the impact was much more profound:

In 2021, we conducted a study of elections that occurred between 2012-2020 and found that 54 cities that moved their off-cycle elections to even years between 2016-2020 tripled their voter participation in municipal elections. The average off-cycle registered voter turnout in these cities, prior to their switch, was 25.54%. The average on-cycle registered voter turnout, after their switch, was 75.81%.⁴ The study showed that the increase in votes cast significantly outpaced growth in voter registration.

Our research makes clear that consolidating elections with statewide elections will help more voters participate in important local elections that impact the well-being of the city.
