| 12 | WHEREAS, Members of the Small Business Commission are subject to a Statement of |
| 13 | Incompatible Activities ("SIA") that guides employees of the Office of Economic and Workforce |
| 14 | Development ("OEWD") and members of the SBC about the kinds of activities that are |
| 15 | incompatible with their public duties and therefore prohibited; and |
| 16 | WHEREAS, Section 3.218 of the Campaign and Governmental Conduct Code |
| 17 | authorizes City employees and officers to seek an Advance Written Determination ("AWD") |
| 18 | from their employer or appointing officer that a proposed activity is or is not incompatible with |
| 19 | the governing SIA; and |
| 20 | WHEREAS, An AWD that a proposed activity is not incompatible with the applicable |
| 21 | SIA provides the requestor with immunity from any subsequent enforcement action for |
| 22 | violation of the SIA if the material facts are as presented in the requestor's written submission; |

REQUEST FOR ADVANCE WRITTEN DETERMINATION

Under section 3.218 of the San Francisco Campaign and Governmental Conduct Code, each Department, Board, or Commission has adopted a Statement of Incompatible Activities ("SIA") that lists those outside activities that are inconsistent or incompatible with the duties of the officers and employees of the Department, Board, or Commission. An officer or employee may also seek a written opinion from the Ethics Commission to determine whether the person's proposed activities violate the SIA or any other local law relating to conflicts of interest and governmental ethics.

To obtain a written Determination, please fill out Sections A-E legibly and completely, and submit this form to the Decision-Maker indentified in Section C. Please note that the Decision-Maker may require you to provide additional information in order to make a Determination. At any time, the Decision-Maker may revoke the Determination, by providing written notice to you specifying the changed facts, circumstances or other good cause that warrants the revocation.
