Resolution declaring August 2, 2022, as Tom Nolan Day in the City and County of San Francisco in recognition of Tom Nolan's lifetime of exemplary public service and on the occasion of his well-deserved retirement.

WHEREAS, Tom Nolan's extraordinary career in public service began with his election to the San Mateo County Board of Supervisors in 1984, making him one of the first openly gay elected officials in the United States, where he served until 1993, including as the first openly gay President of a county Board of Supervisors in California; and

WHEREAS, Tom championed efforts to acquire the 52-mile rail corridor between San Francisco and San Jose, and from 1987 to 1992 served as the first Chair of the newly formed Peninsula Corridor Joint Powers Board, earning him the nickname "Father of Caltrain"; and

WHEREAS, In 1994, Tom moved to San Francisco to become the Executive Director of Project Open Hand, a non-profit organization providing food delivery service to people living with HIV/AIDS, a role in which he served for 17 years, during which time he nearly doubled the organization's reach to include service for people living with other chronic illnesses; and

WHEREAS, Tom served on the San Francisco Municipal Transportation Agency's Board of Directors from 2006 to 2017, including as Chair after 2009, in which role he spearheaded bold initiatives like Free Muni for seniors, youth, and people with disabilities, launching new Muni routes, and making San Francisco the first city in California to adopt a Vision Zero commitment to ending traffic fatalities; and

WHEREAS, In 2012, Tom joined the Department of Aging and Adult Services, now the Department of Disability and Aging Services (DAS), as the agency's LGBTQ Programs Manager; and

1	WHEREAS, Tom coordinated the efforts of the LGBT Aging Task Force, which in 2014
2	issued the report "LGBT Aging at the Golden Gate" that laid out a series of recommendations
3	addressing the unique challenges of the older adult LGBTQ community; and
4	WHEREAS, Under Tom's leadership, DAS has implemented a series of LGBTQ
5	programs including the LGBTQ Care Navigation Program, LGBT Dementia Care Project,
6	LGBTQ Financial Literacy Program and Housing Subsidy Program, and partnered with Open
7	House to develop over 100 units of LGBTQ-affirming affordable housing; and
8	WHEREAS, In 2020, at the onset of the COVID-19 pandemic, Tom joined former
9	members of the LGBT Aging Task Force to convene a regular working group focused on
10	meeting the unique needs of LGBTQ seniors during the pandemic; and
11	WHEREAS, Tom's service to the LGBTQ community has been recognized by
12	organizations including the Curry Senior Center, Positive Resource Center (PRC), National
13	AIDS Memorial Grove, and Richmond/Ermet Aid Foundation;
14	WHEREAS, Tom has received the American Public Transit Association's Outstanding
15	Public Transportation Board Member Award, the KQED Community Hero Award, the
16	California Transportation Foundation's Person of the Year Award, and a host of other
17	accolades, including a plaque honoring his achievements at the Castro Muni station; and
18	WHEREAS, Tom's service to the City and County will be concluding on August 2,
19	2022, with his well-earned retirement; now, therefore, be it
20	RESOLVED, That in celebration and appreciation of Tom's outstanding
21	accomplishments and lifetime of exemplary public service, the Board of Supervisors does
22	hereby declare August 2, 2022, to be Tom Nolan Day in the City and County of San
23	Francisco.
