7 WHEREAS, Ramon Oropeza Sr. pioneered in various professions since the young age  
8 of 17, with an unwavering drive and determination to provide for his family and succeed in the  
9 business world; his humble beginnings taught him the value of hard work and contributed to  
10 the development of his skills in economics early on; and

11 WHEREAS, In 1963, Ramon Oropeza Sr. and wife Inocencia Oropeza, natives of  
12 Mexico, began their journey in the great and diverse city of San Francisco, where they raised  
13 seven children that all grew up to receive private elementary and high school education, and
