7 WHEREAS, Polytechnic High School (Poly) was the first public high school in San  
8 Francisco, California from 1884 until 1973; and

9 WHEREAS, Polytechnic High School was located with entrances at 701 Frederick  
10 Street and exits at 372 Carl Street, and was bordered by Willard and Arguello Streets in San  
11 Francisco, California; and

12 WHEREAS, Kezar Stadium was originally a part of Poly's athletic facilities, and over  
13 50,000 people attended Poly's football games against Lowell High School in both 1928 and  
14 1947; and

15 WHEREAS, Polytechnic High School notable alumni includes former 49ers head coach  
16 George Seifert, former Secretary of Defense Caspar Weinberger, pro footballer Bob St. Clair,  
17 musician Paul Desmond, actress Janet Gaynor, lead singer Victor Willis of Village People,  
18 Nobel Prize in Physics recipient Luis Walter Alvarez, artist Louis Macouillard, cartoonist Tad  
19 Dorgan, physicist Edward Ginzton, athlete Alice Marble - International Tennis Hall of Fame,  
20 musician Merl Saunders, announcer George Fenneman, and Rudy Rintala, a four-sport star



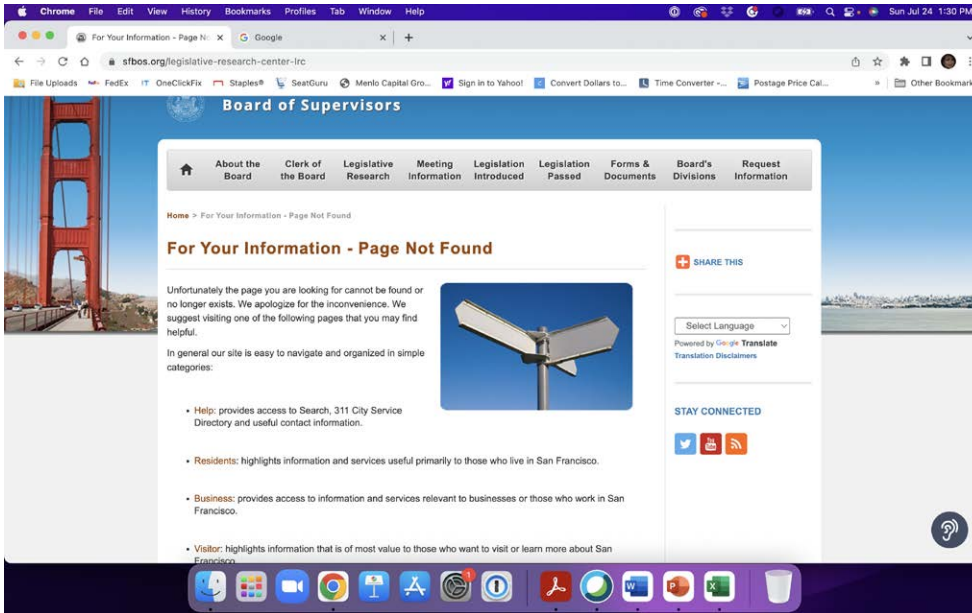

I am strongly against adding the street name “Polytechnic Way” to the 600 block of Frederick Street, base on several reasons:

First, according to the Wikipedia, it has never mentioned the Polytechnics H.S was the San Francisco first public high school. They only mentioned the Mission H.S is the oldest high school in SF. During that period, a lot of High School were built after reconstruction of the school system in SF.

Second, if you look at the pictures below. On Frederick Street already has a cornerstone to commemorate the Polytechnic H.S. In addition, the original boys and girls gymnasiums are still on the Frederick Street. My suggestion is that the City can rename the gymnasiums to the “Polytechnic Gymnasium”. Plus, the cross street is the Kezar Stadium located. When 1950, the Polytechnic H.S Vs. the Lowell H.S had 50,000 attendants, it has broken the High School football game record. The Kezar is also able to rename to Polytechnic Stadium to commemorate the High School.

Third, the original Polytechnic H.S was located on Powell Street between Clay and Sacramento in 1884, then the school was moved to Bush and Stockton Street. After the 1906 SF earthquake, the school was relocated again to the 701 Frederick Street in 1912. Meaning, if the City wants to add the commemorative street name to the existing street. The City should add “Polytechnic Way” to the Powell Street or Bush Street , definitely not Frederick Street.

Finally, as a Frederick street resident, after I have talked to my neighbors. This proposal will create a lot of inconvenience to us, which includes mess up our bankings, credit cards, hospitals, retirements, communication to our relatives, friends and other related address issues, etc.



In conclusion, I and my neighbors are strongly against the proposal adding  
“Polytechnic Way” to the 600 block of Frederick Street.

I am currently a resident on the 600 block of Frederick Street and have lived on this street since the 1990s. Renaming the street will be cause complications and confusion not just for the residents but also for the few businesses and the Kesar Stadium on the street. For dedication – there is already a nice monument and plaque at the site.

First off, the notice we residents recently received is for File #220771 was mailed to us with only a 10 day notice. We received a previous notice last year (for November 1, 2021) File #210744 but it states renaming the 700 block of Frederick which does not exist. This is confusing in itself. Did the 700 Frederick (wrong street) notice got approval for the 600 Frederick Street?

Secondly, renaming the street will be a headache, time consuming and cause complications. Having to change your address with your employer, financial institutions, insurances (home, health, car, etc), doctor offices, friends, family, business associates, DMV, etc. Our mail and packages may be lost/returned because the new street may not be reflected in their databases or navigation for months or years ( Google, USPS, Fed Ex, UPS).

Thirdly, confusing for directions. Frederick Street starts at Buena Vista Ave West and goes for 5-6 blocks west then it suddenly becomes “Polytechnic Way”? for 1 short block and then it feeds into Lincoln Way. This short 1 block break will confuse most people weather giving directions or taking directions.

Lastly, there is already a big monument and plaque dedicated to the history of Polytechnic High school. It is located at the end of the condominiums next to the Circus Center (old school gym). Come and see the monument. We don't need this street name changed it will

only cause more confusion and headache for everyone living and working on this street.

I am very disappointed in such lack of adequate time prior to getting notice to more of my neighbors and for more of us to try to be able to attend this hearing, whether virtual or not.

I am currently a resident on the 600 block of Frederick Street and have lived on this street since the 1990s. Renaming the street will be cause complications and confusion not just for the residents but also for the few businesses and the Kesar Stadium on the street. For dedication – there is already a nice monument and plaque at the site.

First off, the notice we residents recently received is for File #220771 was mailed to us with only a 10 day notice. We received a previous notice last year (for November 1, 2021) File #210744 but it states renaming the 700 block of Frederick which does not exist. This is confusing in itself. Did the 700 Frederick (wrong street) notice got approval for the 600 Frederick Street?

Secondly, renaming the street will be a headache, time consuming and cause complications. Having to change your address with your employer, financial institutions, insurances (home, health, car, etc), doctor offices, friends, family, business associates, DMV, etc. Our mail and packages may be lost/returned because the new street may not be reflected in their databases or navigation for months or years ( Google, USPS, Fed Ex, UPS).

Thirdly, confusing for directions. Frederick Street starts at Buena Vista Ave West and goes for 5-6 blocks west then it suddenly becomes “Polytechnic Way”? for 1 short block and then it feeds into Lincoln Way. This short 1 block break will confuse most people weather giving directions or taking directions.

Lastly, there is already a big monument and plaque dedicated to the history of Polytechnic High school. It is located at the end of the condominiums next to the Circus Center (old school gym). Come and see the monument. We don't need this street name changed it will only cause more confusion and headache for everyone living and working on this street.

# Some challenges we face implementing the LGBTQ+ CHS

Ongoing challenges to operating and opening new nightlife businesses that are key to our District's identity, especially related to development pressure, zoning, and more recently the impacts of COVID-19

Closure of community institutions like the Center for Sex and Culture, and an overall lack of space in which to host community-oriented programming and offer services

Administrative hurdles to placemaking efforts that many Cultural Districts have shown interest in, including post wraps and banners

# Ways to support strategy implementation

Outreach to the LEATHER & LGBTQ Cultural District to engage in updates to future iterations of the LGBTQ+ Cultural Heritage Strategy, since much of the engagement predates the District

A greater focus on supporting nightlife and entertainment spaces in the plan, especially since the legislation that led to the report's creation also called for a nightlife focus. Strategies might include new land use or sound permitting rules to protect venues or simply new planning methods that better take nightlife stakeholders into account

Greater integration of the Cultural Districts with both citywide and District-specific historic preservation efforts from the city to offset development pressure

# HSA Initiatives Supporting Well-being for LGBTQ+ Communities

- Curry Senior Center and Openhouse programs for transgender and gender nonconforming older adults and adults with disabilities
- Alzheimer's Association's [LGBT Dementia Care Project](#), offering a suite of free trainings to health and social services providers.
- [LGBTQ Care Navigation and Peer Support Programs](#), providing compassionate supportive services for those at risk of isolation.
- Legal Assistance to the Elderly providing tailored services for end of life planning [for LGBTQ+ older adults and adults with disabilities](#)



# HSA Initiatives Supporting Well-being for LGBTQ+ Communities

- Conducted an assessment of the needs of LGBTQ+ older adults and disabled people of color
- Trained our child welfare staff on Sexual Health and Wellness for Foster Youth
- Provide mandatory training to all resource families, and offer intervention and support for parents, to support LGBTQ+ children and youth in the child welfare system



# HSA Initiatives Supporting Well-being for LGBTQ+ Communities

- Instituted LGBTQ+ cultural sensitivity training for all employees across the Human Services Agency.
- Partnered with Openhouse to offer trainings:
  - LGBTQ+ Aging Cultural Humility for DAS service providers.
  - SOGI data collection for all SFHSA service providers



# HSA Initiatives Supporting Opportunities for LGBTQ+ Communities

- SF LGBT Center's Transgender Employment Program (TEP) creates inclusive workplaces and jobs for TGNC individuals



# LGBTQ+ Programming in Response to COVID-19

- Give2SF funds allocated to LGBTQ+ communities:
  - \$75,000 in gift cards distributed for food purchases.
  - SF LGBT Center was lead CBO with sub-grants to El/La Para TransLatinas, TGI Justice Project, & TurnOut.
- COVID-centered survey of LGBTQ+ older adults.
- Food coordinator position within Openhouse created to organize volunteers and connect LGBTQ+ persons with food resources.





# LGBTQ+ Programming in Response to COVID-19

- Funded mental health survey of 500 LGBTQ+ adults age 50+.

During COVID:

- 3x percentage of LGBTQ+ older adults reporting symptoms of depression
- Over 80% said they felt isolated from others
- Nearly 65% of respondents felt lonelier than before the pandemic began
- Mental health counseling was the highest unmet need
- Mental health telehealth pilot serving LGBTQ+ older adults and HIV long term survivors
- Investing in nonprofit staffing to expand and improve service connections

- Challenge
  - LGBTQ+ consumers access services at much lower rates than the overall population.
- Strategy
  - Strengthening service provider capacity, with focus and intentionality in providing inclusive services
  - Launching Online Resource Directory, which will:
    - Provide information on a broad range of resources and services.
    - Link people directly to services through online referrals.
  - Customize outreach to LGBTQ+ population



# Challenges & Strategies

- Challenge:
  - Response rates are still lower for SOGI demographic questions, making it hard to assess true need
- Strategy:
  - Seeking [input and continued partnership](#) with LGBTQ+-serving CBOS and leaders on community need and gaps
  - Seeking [input and continued partnership](#) with other City departments in increasing our reach to this community and reducing data gaps

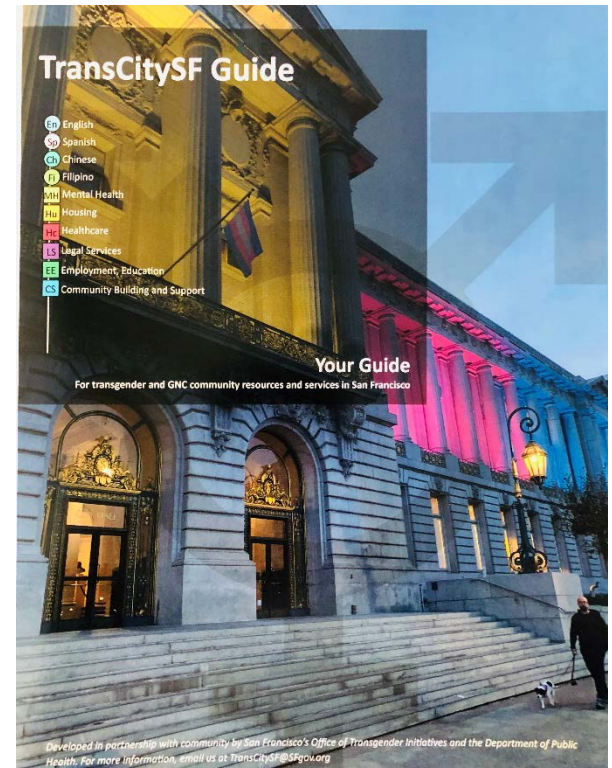

  - During height of COVID-19 pandemic, OTI staff were deployed as DSWs to support community engagement and referrals of LGBTQ+ people experiencing homelessness into SIP hotels
  - Provide navigation support to individual residents and providers





# Well-Being Initiatives

- **Trans inclusion trainings for City employees [W3]:**
  - Since 2020, trained thousands of City employees from multiple City agencies: SFFD, DHR EEO, DPH, SFMTA, DAT, SFO, DPA, DPW, SFPL, etc.
  - In November 2021, launched Trans 101 e-module available to all City employees through SF Learning portal, and new training webpage with resources for ongoing education.
- **SOGI data collection trainings (live and recorded) [W3]**





## Culture Initiatives

- **Support LGBTQ+ Cultural Districts [C1]:**
  - With The Transgender District, launched last year's proclamation of August as Trans History Month in San Francisco, and organize annual Trans History Month flag raising
- **Partner with community-based organizations to support key annual events:** Trans Day of Visibility, Trans March, Trans Day of Remembrance, etc.

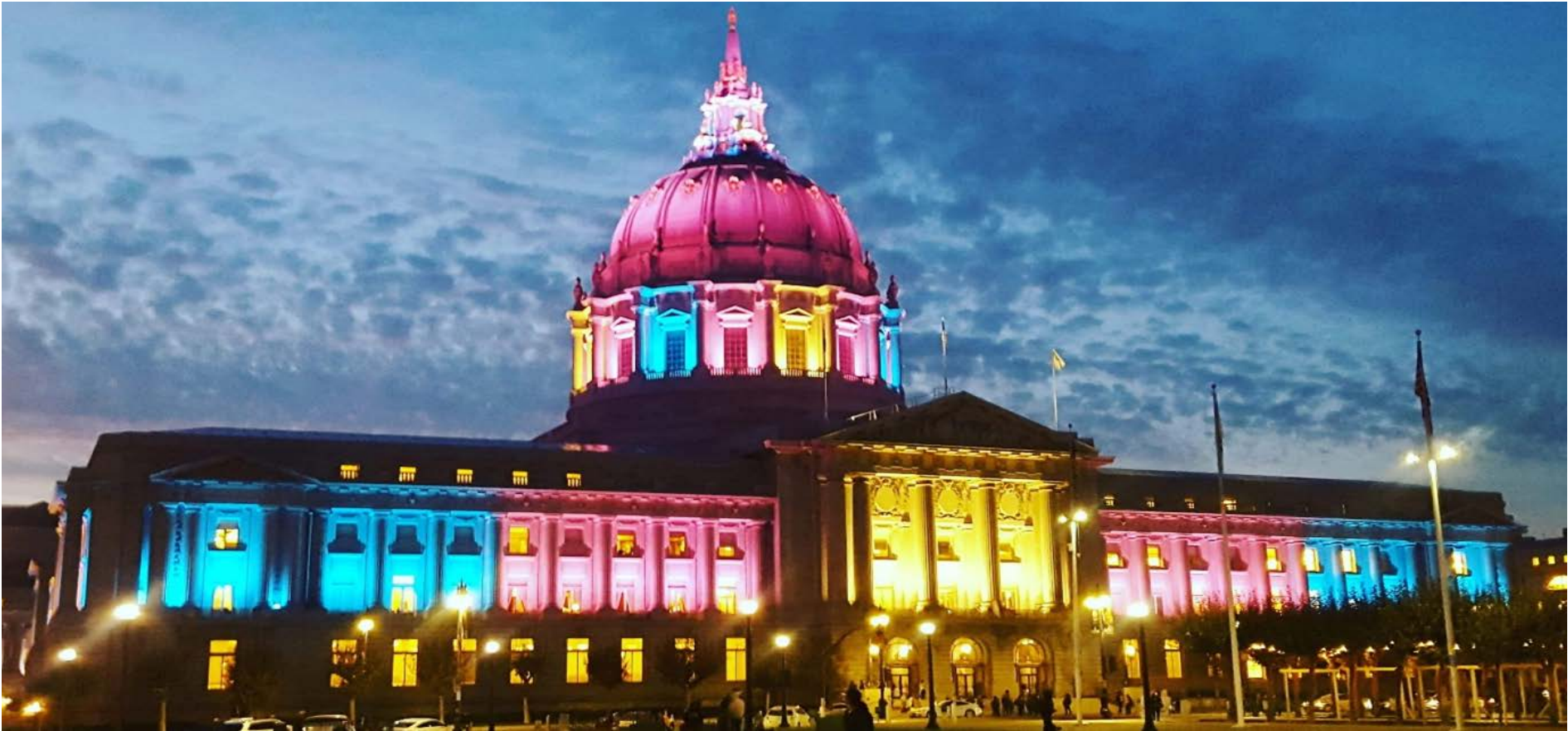

# Challenges and Barriers to Full Implementation

- **Current OTI staffing** insufficient to address needs of TGNC residents, let alone LGBTQ+ residents
- **Lack of data on LGBTQ+ residents** and the inequities we face – leads OTI to dedicate significant resources towards developing data estimates and integrating data collection into existing City surveys
- **City bureaucracy** creates significant challenges for community-based organizations to apply for, and receive, grants
- **City funding for trans and LGBTQ+ issues is insufficient to meet the need** -- causes fractures between community-based organizations competing for resources

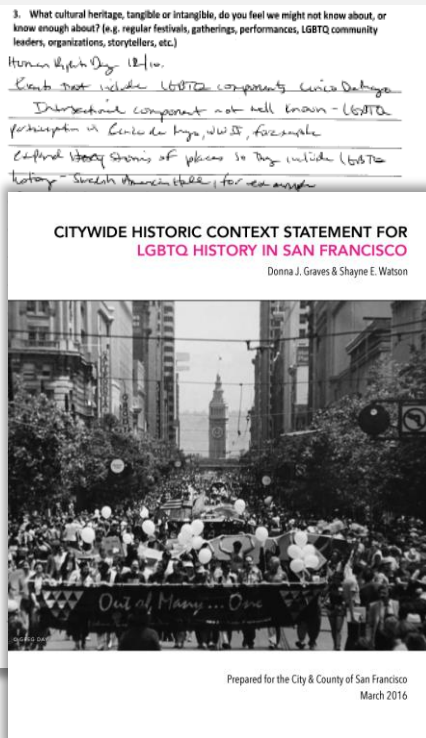

# Establishing a Permanent Museum of LGBTQ+ History & Culture




## Major Milestones

- 1985 GLBT Historical Society founded.
- 2003 Society establishes its first dedicated gallery space is established, at 657 Mission Street.
- 2008 Pop up museum of LGBTQ+ history at 18th and Castro attracts 10's of thousands of visitors and worldwide press attention.
- 2011 First standalone museum of LGBTQ+ history and culture in the U.S. opens, at 4127 18th street.



## Major Milestones

- 2016 Vision 2020 Campaign kicks off, aiming to build capacity and conduct feasibility research towards opening a new full-scale facility by 2020.
- 2019 Feasibility research phase completed, showing viability of a full-scale museum and research center.
- 2021 Mayor London Breed pledges \$12 million towards the creation of a full-scale museum of LGBTQ+ history and culture.
- 2022 Senator Scott Wiener secures \$5.5 million in state funding to support efforts to create an LGBTQ+ history museum in San Francisco.



# Research Study Conclusions

The feasibility studies completed in 2019 created multiple viable scenarios, ranging from an all-inclusive museum and research center of 40-60,000 square feet to scenarios that maintain separate museum and research facilities at around 10,000 square feet each.



# GLBT Historical Society Museum Today



- Attracts tens of thousands of visitors each year, more than three times the number of visitors per square foot of similar institutions.
- Regularly receives international press recognition for archives and exhibitions.
- Houses priceless artifacts, including the only known remnant of the original rainbow flags.





# Vision for the Future

As noted in the LGBTQ+ Cultural Heritage Strategy:

“A full-scale museum dedicated to LGBTQ+ history would draw visitors from across the globe to San Francisco, would serve as an important educational tool, and would play a vital role in honoring LGBTQ+ cultural heritage.”



# Vision for the Future

Establishing a permanent museum of LGBTQ+ History and Culture is a cornerstone of San Francisco's LGBTQ+ Cultural Heritage Strategy.

Continued support from the City and County of San Francisco is crucial in moving this project closer to completion.
