[Approving Public Works Rules and Regulations for Vendor Permit Program]

Resolution approving proposed rules and regulations pursuant to Section 5.9-8 of Article 5.9 of Public Works Code, enacting permit regulations for vendors selling legitimately acquired goods on the streets.

WHEREAS, In April 2022 The Board of Supervisors unanimously passed an Ordinance establishing a vendor permitting system in San Francisco, to be regulated and enforced by the Department of Public Works; and

WHEREAS, It was the intention of this body to create a program that would create a regulatory system that would address the sale of stolen goods on the street and at the same time provide opportunities and guidelines for vendors selling hand-made or legally acquired goods; and

WHEREAS, Built into this Ordinance were requirements that Public Works work with the community to educate and inform vendors of the new regulations and expectations of their behavior; and

WHEREAS, Public Works has worked with the community to do extensive outreach over the course of eight weeks and by all measures has met the expectations of the Board in their community engagement education; and

WHEREAS, This Ordinance also required Public Works to submit their final regulations and rules for implementation of this Ordinance to the Board of Supervisors for approval; and

WHEREAS, Public Works has submitted its proposal to the board and the proposal has been reviewed by the Board; now, therefore, be it

Supervisors Ronen; Safai BOARD OF SUPERVISORS RESOLVED, That the Board of Supervisors approves of the rules and regulations Public Works has submitted, pursuant to Section 5.9-8 of Public Works Code 5.9, and encourages immediate implementation of these regulations; and, be it
