25 starting on May 14, 2022; and

3 available beds in other skilled nursing facilities – including by calling approximately 1,400

5 compromise the health of elderly and/or medically infirm patients, but are being pressured by
6 CMS to be more aggressive with transfers, and CMS is requiring Laguna Honda Hospital to
7 relocate patients that are at high risk of mortality due to transfer trauma and other health
8 conditions; and

9 WHEREAS, There are grave concerns about the danger of relocating and transferring
10 patients who are elderly, frail, or with complicated medical needs that could be further
11 exacerbated by transfer trauma and the possibility of being transported miles away from their
12 family support systems – including across the State or to other States – due to the extreme
13 shortage of skilled nursing beds in the San Francisco Bay Area and the greater State of
14 California; and

25 licensing system that there is a severe shortage of skilled nursing beds and that it is

1 inconceivable that Laguna Honda will be able to relocate over 600 patients to appropriate

16 Officer Dr. Tomás Aragón to withdraw CDPH's approval of the Laguna Honda Closure and
17 Patient Relocation and Transfer Plan, to the extent that it requires transfer of all patients
18 within four months; and, be it

19 FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board
20 to transmit copies of this Resolution to the Office of California Governor Gavin Newsom,
21 Office of California Dr. Tomás Aragón, and the Office of Secretary of Health and Human


