3 **Ordinance authorizing settlement of the lawsuit filed by Linda Howdysshell against the**
4 **City and County of San Francisco for \$750,000; the lawsuit was filed on October 28,**
5 **2020, in San Francisco Superior Court, Case No. CGC-20-587334; entitled Linda**
6 **Howdysshell v. City and County of San Francisco; the lawsuit involves alleged personal**
7 **injury due to a fall from a retaining wall on a raised planter adjacent to a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Linda Howdysshell v. City and County
12 of San Francisco, San Francisco Superior Court Case No. CGC-20-587334, by the payment
13 of \$750,000. The lawsuit involves alleged personal injury due to a fall from a retaining wall on
14 a raised planter adjacent to a City sidewalk.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 28, 2020, and the following parties were named in the lawsuit: plaintiff: Linda
17 Howdysshell; defendant: City and County of San Francisco.
