3 **Ordinance authorizing settlement of the lawsuit filed by Rebecca Michaels against the**  
4 **City and County of San Francisco for \$280,000; the lawsuit was filed on May 12, 2020,**  
5 **in San Francisco Superior Court, Case No. CGC-20-584429; entitled Rebecca Michaels**  
6 **v. City and County of San Francisco, et al.; the lawsuit involves alleged personal**  
7 **injuries on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Rebecca Michaels v. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-20-584429 by the  
13 payment of \$280,000. The lawsuit involves alleged personal injuries on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on May  
15 12, 2020, and the following parties were named in the lawsuit: Rebecca Michaels, Plaintiff;  
16 City and County of San Francisco, Defendant; Regents of the University of California,  
17 Defendant.
