9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Breonna Richard v. City and County of
12 San Francisco, et al., U.S. District Court Northern District, Case No. 20-CV-04276-JSC by the
13 payment of \$47,500. The lawsuit involves an alleged civil rights violation.
