8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Khalid Barrow v. City and County of
11 San Francisco, et al., United States District Court, Case No. 20-cv-04099 by the payment of
12 \$42,500. The lawsuit involves an alleged civil rights violation.

13 Section 2. The above-named action was filed in United States District Court on June
14 19, 2020, and the following parties were named in the lawsuit: Plaintiff: Khalid Barro;
15 Defendants: City and County of San Francisco, Daniel T. Mills, Omar Prado; Stephen Tilton.
