9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Theresa Moorehouse, San Francisco
12 Superior Court, Case No. CGC-20-587190 by the payment of \$150,000. The lawsuit involves
13 an alleged trip and fall on a City sidewalk.
