

1 [Grant Agreement - Retroactive - Wu Yee Children’s Services - ECE Integrated Services - Not  
2 to Exceed \$144,496,672]

3 **Resolution retroactively approving the grant agreement between the City and County of**  
4 **San Francisco and Wu Yee Children’s Services for the provision of Early Care and**  
5 **Education (ECE) Integrated Services to support the City’s implementation of the San**  
6 **Francisco Citywide Plan For Early Care and Education for the period of July 1, 2022,**  
7 **through June 30, 2024, in an amount not to exceed \$144,496,672.**

9 WHEREAS, The City and County of San Francisco wishes to provide Early Care and  
10 Education Integrated Services by delivering subsidy administration and resource and referral  
11 services; and

12 WHEREAS, The Office of Early Care and Education (“OECE”), under the auspices of  
13 the Human Services Agency, conducted a Request for Proposals for these services in  
14 October 2021; and

15 WHEREAS, Wu Yee Children’s Services submitted a responsive and responsible  
16 proposal and was awarded the grant in February 2022 in an amount not to exceed  
17 \$144,496,672; and

18 WHEREAS, The Human Services Agency Commission approved the Wu Yee  
19 Children’s Services grant agreement at its meeting of June 23, 2022; and

20 WHEREAS, It is anticipated that legislation will be introduced at the Board of  
21 Supervisors in July 2022 to consolidate the Office of Early Care and Education with the First  
22 Five Commission, resulting in a new Department that will succeed the OECE (“Successor  
23 Agency”); and

1           WHEREAS, Upon its establishment, the Successor Agency is expected to assume  
2 responsibility for contracts and grants that had previously been overseen by OECE; now,  
3 therefore, be it

4           RESOLVED, That the Board of Supervisors hereby approves award of this grant with  
5 Wu Yee Children's Services to provide Early Care and Education Integrated Services, for the  
6 period of July 1, 2022, through June 30, 2024, in the amount of \$144,496,672; and, be it

7           FURTHER RESOLVED, That within thirty (30) days of the grant agreement being fully  
8 executed by all parties, the OECE or the Successor Agency shall provide the final grant to the  
9 Clerk of the Board for inclusion into the official file.
