Resolution retroactively approving the grant agreement between the City and County of San Francisco and Wu Yee Children's Services for the provision of Early Care and Education (ECE) Integrated Services to support the City's implementation of the San Francisco Citywide Plan For Early Care and Education for the period of July 1, 2022, through June 30, 2024, in an amount not to exceed \$144,496,672.

WHEREAS, The City and County of San Francisco wishes to provide Early Care and Education Integrated Services by delivering subsidy administration and resource and referral services; and

WHEREAS, The Office of Early Care and Education ("OECE"), under the auspices of the Human Services Agency, conducted a Request for Proposals for these services in October 2021; and

WHEREAS, Wu Yee Children's Services submitted a responsive and responsible proposal and was awarded the grant in February 2022 in an amount not to exceed \$144,496,672; and

WHEREAS, The Human Services Agency Commission approved the Wu Yee Children's Services grant agreement at its meeting of June 23, 2022; and

WHEREAS, It is anticipated that legislation will be introduced at the Board of Supervisors in July 2022 to consolidate the Office of Early Care and Education with the First Five Commission, resulting in a new Department that will succeed the OECE ("Successor Agency"); and

WHEREAS, Upon its establishment, the Successor Agency is expected to assume responsibility for contracts and grants that had previously been overseen by OECE; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves award of this grant with Wu Yee Children's Services to provide Early Care and Education Integrated Services, for the period of July 1, 2022, through June 30, 2024, in the amount of \$144,496,672; and, be it

FURTHER RESOLVED, That within thirty (30) days of the grant agreement being fully executed by all parties, the OECE or the Successor Agency shall provide the final grant to the Clerk of the Board for inclusion into the official file.
