

1 [Contract Amendment - Denali Water Solutions LLC - Biosolids and Grit Hauling
2 Services Oceanside and Southeast Wastewater Treatment Plants - Not to Exceed
3 \$18,800,000]

4 **Resolution authorizing the Office of Contract Administration to amend PeopleSoft**
5 **Contract ID 1000015461 between the City and County of San Francisco and Denali**
6 **Water Solutions LLC for the hauling of biosolids and grit from Public Utilities**
7 **Commission's Oceanside and Southeast wastewater treatment plants, increasing**
8 **the contract amount by \$10,200,000 for a total not to exceed amount of**
9 **\$18,800,000 and extending the contract end date by four years, with a contract**
10 **duration of seven years for a total term of October 1, 2019, through September 30,**
11 **2026.**

13 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to
14 approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

15 WHEREAS, The contract referenced above is on file with the Clerk of the Board of
16 Supervisors in File No. 220923, which is hereby declared to be part of this Resolution as
17 if set forth fully herein; and

18 WHEREAS, This Contract was competitively procured as required by
19 Administrative Code, Chapter 21.1, through an Invitation for Bids issued by the Office of
20 Contract Administration on April 2, 2019, under Sourcing Event 0000001515 for the
21 provision of Biosolids and Grit Hauling Services; and

22 WHEREAS, Sourcing Event 0000001515 resulted in the primary award of
23 Aggregate 1 to Denali Water Solutions as the lowest responsive bidder (PeopleSoft
24 Contract ID 1000015461) with an LBE subcontracting participation requirement of 7%;
25 and

1 WHEREAS, Amendment 1 to the contract executed on April 13, 2022 decreased
2 the Not to Exceed (NTE) amount from \$8,700,000 to \$8,600,000; and

3 WHEREAS, Annually, the Oceanside and Southeast wastewater treatment plants
4 produce approximately 60,000 tons of biosolids which are nutrient rich solids produced
5 during wastewater and 4,000 tons of grit which is sand removed from the wastewater
6 before treatment; and

7 WHEREAS, The hauling of biosolids and grit from San Francisco Public Utilities
8 Commission's (SFPUC) Oceanside and Southeast wastewater treatment plants is critical
9 for the daily operation of the City's wastewater treatment infrastructure; now, therefore,
10 be it

11 RESOLVED, That the Board of Supervisors, under Charter, Section 9.118(b),
12 hereby authorizes the Purchaser and Director of the Office of Contract Administration
13 to enter into amend PeopleSoft Contract ID 1000015461 between the City and County
14 of San Francisco and Denali Water Solutions LLC for the hauling of biosolids and grit
15 from PUC's Oceanside and Southeast wastewater treatment plants, increasing the
16 contract amount by \$10,200,000 for a total not to exceed amount of \$18,800,000 and
17 extending the contract end date by four years to September 30, 2026, with a total
18 contract duration of seven years; and, be it

19 FURTHER RESOLVED, That within 30 days of the contracts being fully
20 executed by all parties, the Purchaser shall provide the final copies of the contracts to
21 the Clerk of the Board for inclusion into the official file.






