3 **Resolution extending the termination date of the Power Plant Task Force to December**  
4 **31, 2011.**

6 WHEREAS, By Resolution 362-99, the Board of Supervisors created a Potrero Power  
7 Plant Citizens Advisory Task Force to advise the City and County of San Francisco regarding  
8 the sale, operation and maintenance of the Potrero Power Plant; and

9 WHEREAS, The Task Force was formed in response to the concerns of San Francisco  
10 residents about the impacts of the planned closure of the Hunters Point Power Plant and the  
11 sale of the Potrero Power; and

12 WHEREAS, The Board of Supervisors authorized the Task Force to provide the City  
13 with input on 1) issues which adversely affect the surrounding Bayview Hunters Point and  
14 Central Waterfront neighborhoods such as noise, construction, and harmful emissions, 2)  
15 power plant workers' safety issues, and 3) any other related issues deemed appropriate by  
16 the Task Force; and

17 WHEREAS, By Resolutions 1055-00, 139-01, 366-01, 879-01, 733-02, 119-04, 386-04,  
18 807-05, 416-06, 100-08, and 504-09, the Board of Supervisors has amended the appointment  
19 process, adjusted the membership of the Task Force, renamed it the "Power Plant Task  
20 Force" and extended its life so that it may advise the Board of Supervisors on power policy  
21 issues related to the potential construction of new power generating facilities in the Southeast  
22 portion of San Francisco, the closure of existing facilities, power demand management, and  
23 on energy policy for the City; and

1           WHEREAS, The Task Force continues to perform a valuable service to the City  
2 through its examination of issues of concern to San Francisco residents such as the City's  
3 Energy Resource Plan, the Trans Bay Cable Project, and the ongoing effort to close the  
4 entirety of Mirant Corporation's Potrero Power Plant; and

5           WHEREAS, The Public Utilities Commission is updating the Electricity Resource Plan  
6 in consultation with the Task Force; and

7           WHEREAS, The Potrero Power Plant has not yet permanently closed; and,

8           WHEREAS, The Task Force members represent a variety of community viewpoints on  
9 power plant issues and the City's energy policy and have developed expertise on these  
10 matters that can assist the Board of Supervisors; now, therefore, be it

11           RESOLVED, That the Board of Supervisors extends the term of the Power Plant Task  
12 Force from December 31, 2010 to December 31, 2011.




