3 **Ordinance authorizing settlement of the lawsuit filed by Theodore Belizaire against the**  
4 **City and County of San Francisco for \$186,642.33; the lawsuit was filed on July 20,**  
5 **2020, in San Francisco Superior Court, Case No. CGC-20-585672, entitled Theodore**  
6 **Belizaire v. City and County of San Francisco; the lawsuit involves alleged personal**  
7 **injuries in a collision with a City vehicle; other material terms of the settlement include**  
8 **payment of \$99,142.33 to Zuckerberg San Francisco General Hospital for a medical lien.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Theodore Belizaire v. City and County  
13 of San Francisco, San Francisco Superior Court, Case No. CGC-20-585672 by the payment  
14 of \$87,500 to plaintiff and the payment of \$99,142.33 to Zuckerberg San Francisco General  
15 Hospital for a medical lien. The lawsuit involves alleged personal injuries from a vehicle  
16 collision.

17 Section 2. The above-named action was filed in San Francisco Superior Court on July  
18 20, 2020, and the following parties were named in the lawsuit: Theodore Belizaire, Plaintiff;  
19 City and County of San Francisco, Defendant.
