8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Donna James v. City and County of
11 San Francisco, United States District Court, Case No. 3:21-cv-02939-RS by the payment of
12 \$125,000. The lawsuit involves an employment dispute.
