



We intend to continue operating the same or reduced hour as we have for the past 20 years 10am to 2am whenever possible.

Conary & Murphy filed the application for a license exchange at the San Francisco ABC office on July 5<sup>th</sup> 2022 and posted a notice of filing also on the premises at 217 Kearny St the same day.

On July 12 we mailed letters to property owners with residence within 500ft of our intent to apply for a license change.

Murphy's Pub has been doing business on Kearny St for the past 20 years but due to the pandemic and lack of office workers returning to the financial district we are unable to sustain our food operation. We are applying for the change in license to help reduce operating costs in the hopes that we can stay in business until such time as the office workers return on a consistent and regular basis. Thus allowing us to return to full operations at a sustainable level some day in the future for the service and betterment of the neighborhood.
