Japantown Buchanan Mall Project

In the cultural heart of San Francisco's Japantown, this project will implement improvements to the Japantown Buchanan Mall, a culturally significant public plaza. The project will focus on three main priorities: 1) Enhancing accessibility of the mall for seniors and people with disabilities and limited mobility 2) Rehabilitate the existing Ruth Asawa fountains, 3) Support the business community by embellishing the sense of cultural authenticity and enhancing commercial edges of the mall.

Work will include repaying the side walkways, planting more trees, landscaping with culturally relevant plants, and enhancing the existing historic public art (historic fountains, cobblestone river and Torii gate) with new, complementary public art; encouraging businesses to provide outdoor seating and displays along the storefronts; and utilizing new energy- and water-efficient technologies to light the plaza and maintain the fountains.
