3 **Ordinance authorizing settlement of the lawsuit filed by Brandon Murphy against the**
4 **City and County of San Francisco for \$50,000; the lawsuit was filed on January 10,**
5 **2019, in San Francisco Superior Court, Case No. CGC-19-572705; entitled Brandon**
6 **Murphy v. Regents of The University of California, et al.; the lawsuit involves alleged**
7 **personal injury from medical negligence.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Brandon Murphy v. Regents of The
11 University of California, et al., San Francisco Superior Court, Case No. CGC-19-572705 by
12 the payment of \$50,000. The lawsuit involves alleged personal injury from medical
13 negligence.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 10, 2019, and the following parties were named in the lawsuit: Plaintiff Brandon
16 Murphy; Defendants The Regents of The University of California, City and County of San
