Honorable Supervisors,

The Rules Committee will act tomorrow on recommendations for the re-appointments to the Historic Preservation Committee and one new appointment, and the full Board will hear the cases on Tuesday.

I am writing in support of the reappointments of Commissioners Andrew Wolfram and Karl Hasz but would like to urge you to reject the appointment of Richard Johns who does not fulfill the requirement of being a professional historian and thus does not seem to qualify. While Mr. Johns professional qualifications as a lawyer and as a volunteer serving as the president of the SFMHS are impressive they do not coincide with the qualification of a professional historian. Compliance with the requirements of Proposition J are necessary to maintain the status of the City and County of San Francisco as a Certified Local Government and its eligibility for grants.

Please consider re-appointing James Buckley Ph.D. or appointing Professor Robert Cerny Ph.D. for seat four on the Historic Preservation Commission. Both are highly qualified historians with a strong background in San Francisco history.
