8 Be it ordained by the People of the City and County of San Francisco:


9 Section 1. Mayor Gavin Newsom established a reward fund of \$10,000 to be paid to
10 any individual or individuals supplying information leading to the arrest and conviction of the
11 person or persons responsible for the deaths of Mark Ashley. During the course of
12 investigation of the death, a witness came forward with information leading to an arrest and
13 conviction of the person responsible for the death of Mark Ashley.

14 Section 2. The Controller of the City and County of San Francisco is hereby authorized
15 to draft warrants upon the treasury of the City and County of San Francisco totaling ten
16 thousand dollars and no cents (\$10,000) to be paid to the John Doe who supplied the
17 information leading to arrest and conviction.


