2021 Project Homekey funds would be used to supplement local funding to purchase the property located at 333 12<sup>th</sup> Street and provide a minimum of 5 years of operating funds for the housing site. The property has 200 multi-family units that would be used as Permanent Supportive Housing for Families. Based on the affordability restrictions, HSH plans to request annual appropriations to provide ongoing operating support for the project through the 15-year restriction period.
