10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Aliitasi T. Alapati v. City and County of  
12 San Francisco, et al, United States District Court, Case No. 21-cv-04144-SI by the payment of  
13 \$100,000. The lawsuit involves an alleged civil rights violation.
