7	WHEREAS, Pursuant to Administrative Code, Section 16.93-3, the City
8	Administrator's Office reviewed all applications and recommended to the Board of

11	WHEREAS, On April 19, 2022, the Board approved a Resolution in Board File No.
12	220251 designating all the federated agencies as qualified to participate in the Annual
13	Fundraising Drive because they met the requirements contained in the Administrative

15	WHEREAS, The City Administrator's Office wishes to clarify its interpretation of
16	the criteria in Administrative Code, Section 16.93-2(a), as follows:

Combined Charities Program

Administrative code requirements, processes, and options for the annual Combined Charities program.

Administrative Code Requirements

Admin Code Sec 16.93-1 (codified in 1988) **requires** the City hold an Annual Joint Fundraising Drive.

• **Eligibility**: Certain Mayor's funds and **all** federated agencies that apply and meet defined criteria (established in 1988 and updated in 1997).

• Roles:

- Mayor: Designates a Campaign Chair;
- Controller: Provides technical support for deductions;
- City Administrator: Reviews/recommends applications.

Timeline:

- March 1: Applications due, Campaign Chair designated, and Chair reports to BoS on prior year.
- May 1: BoS designates approved federations.

Administrative Code Requirements

Participating Federations Must:

- Represent 10 or more charitable organizations
 - At least 50% must be organizations located in SF, San Mateo, Santa Clara, Alameda, Contra Costa or Marin counties;
- Certify that contributions are tax deductible;
- Have been in existence for 1 year;
- Submit annual certified audits; and,
- Apply to the Board of Supervisors to participate each year.

Annual Process

- Interested federations must apply to the Board of Supervisors annually;
- Applications are sent to the City Administrator's Office to review against the requirements of the Administrative Code;
- City Administrator's Office recommends whether applicants qualify to participate in the annual drive.
- Board reviews the qualified federations and approves a list via resolution.
 - This year: April 19, 2022 (Resolution 160-22)

Participation and Resources

- Roughly **3,000** City employees participate annually with total annual contributions of **\$1.2 million** last year.
- Donations are post-tax, but tax deductible.
- Federations receive an administrative fee for contributions (up to 15%).
- City resources (staff time) associated with the program:
 - **Board of Supervisors**: Receive applications, review resolution;
 - **City Administrator's Office**: Review Admin Code criteria and prepare recommendations;
 - **Controller's Office**: Implement payroll deductions and manage individual check donations;
 - Sheriff's Department and Airport: Coordinate website and prepare campaign materials and communications to distribute;
 - **Citywide staff**: Department champions to communicate and motivate participants.

2022 Timeline and Current Status

- **April 19, 2022** Board of Supervisors approved Resolution No. 160 22 identifying participating federations and charities for the 2022 Annual Drive (with deductions to be taken in the 2023 calendar year.
- **Oct 1, 2022** Annual "Heart of the City Combined Charities" Drive kicks-off.
- **Oct 10, 2022** (approximately) Employee complaint received by Combined Charity Campaign's lead department (Sheriff's Office).
- **Oct 12, 2022** City temporarily paused the annual drive to evaluate the program.
- **November 4, 2022** Board of Supervisors submits a resolution amending eligible federations for the 2022 Annual Drive.

Proposed Action

Recommend a resolution to replace Resolution 160–22 amending the list of approved federations and associated charities:

- Approved federations will include only those charities that are both located in the Bay Area **and** serve the Bay Area;
- Funds raised through the campaign will be dedicated to services provided in the Bay Area.

Results

- City staff retain the right to write in any charity of their choice, even if it is not represented by a participating federation, through "donor's choice."
- Number of participating federations is reduced from four to three:
 - Creating Healthy Communities (CHC)
 - America's Best Local Charities
 - EarthShare
- Number of charities represented by participating federations is shortened.
- Global Impact is no longer eligible to participate in the campaign.
- Campaign is re-launched.

Options for Future Action

3 Potential Options to consider:

- The Board passes an Ordinance to amend the Administrative Code to alter the criteria for participation in the Campaign;
- The Board passes an Ordinance amending the Administrative Code to limit participation in the campaign to City funds (like Give2SF) and Donor's Choice;
- The Board passes an Ordinance amending the Administrative Code to discontinue the program.

RE:	Proposed Updated List of Federations to Participate in the 2022 Heart of the City Combined Charities Campaign

Summary

The City Administrator's Office is submitting a revised list of Federations authorized to participate in the City's 2022 Heart of the City Combined Charities Campaign, replacing the previous list adopted by Resolution No. 160-22 at the April 19, 2022 Board of Supervisors meeting. [See Attachment A for the previously adopted Resolution, redlined to highlight the difference between the two lists.]

Discussion

Administrative Code Section 16.93-1 requires that the City hold an Annual Joint Fundraising Drive (known as the "Heart of the City Combined Charities Campaign" or "Annual Drive") to facilitate City employee donations to charitable organizations through payroll deductions. [See Attachment B for Administrative Code Sections 16.93-1 to 16.93-5.] Over 3,000 City employees participate in the Annual Drive each year; and last year City employees donated a combined total of approximately \$1.2 million.

Eligible "charitable organizations" are limited to certain Mayor's funds and to "all federated agencies that meet the [established] criteria, as determined by the Board of Supervisors." Employees also have the option of donating directly to *any* other individual tax-exempt non-profit organization of their choice (referred to as "Donor's Choice" donations), provided that the contribution is tax-deductible.

To qualify, Federations interested in participating in the Annual Drive must establish that they meet the following criteria under Administrative Code Section 16.93-2:

- An eligible federation must represent 10 or more charitable organizations, of which at least 50% must represent organizations located in San Francisco, San Mateo, Santa Clara, Alameda, Contra Costa, or Marin counties;
- The federations must certify to the Board of Supervisors that any contribution to the represented charities are tax deductible;
- Federations must have been in existence and representing at least ten charities for a minimum of one year prior to the date of application to participate in the Campaign;
- Federated agencies must submit annual certified audits with their applications; and,
- Federations must apply annually to the Board of Supervisors.

Administrative Code Section 16.93-3 requires that the City Administrator review applications submitted by federated agencies ("Federations") and "recommend to the Board of Supervisors whether applicants qualify to participate in the Annual Drive." The City Administrator's Office is required to forward the list of all eligible Federations to the Board of Supervisors for consideration; it may not include or exclude any Federation(s) based on other factors. In accordance with the proscribed timelines outlined in Administrative Code Section 16.93-4, the Board of Supervisors approved and adopted the list of four eligible Federations (and their member charities) as forwarded by the City Administrator's Office, through Resolution No. 160-22 on April 19, 2022 (Again, see Attachment A).

Shortly after the launch of the 2022 Annual Drive in October 2022, a number of employees raised concerns with listed partner charities. The City temporarily paused the Annual Drive on October 12, 2022 to evaluate the program and process.

Working within the Administrative Code requirements, the City Administrator's Office proposes that additional geographic requirements be placed on Federations interested in participating in the 2022 Annual Drive to ensure a benefit to local communities this year. Specifically, that each participating Federation limit its partner charities to only those that have an office located in the Bay Area and/or that provide services in the Bay Area, as defined by the counties listed under Administrative Code Section 16.93, and that agree to direct donations raised in the Annual Drive to such local offices and/or services.

The proposed amended Resolution identifies the updated list of Federations that have agreed to these additional requirements for the Board's consideration and approval. In addition, the Federations have also further decided to limit partners for the City's 2022 Annual Drive to those charities that also have a confirmed nondiscrimination policy.

As reflected in Attachment A, these changes will have a significant impact on the list of participating organizations. Notably, the additional geographic restriction will serve to exclude Global Impact and its partner charities, which are focused on addressing global issues such as international human trafficking and the need for clean drinking water in other countries (as opposed to providing local services). Please see the attached submission from Global Impact requesting that the Board of Supervisors consider its continued inclusion in the Annual Campaign.

Once the Board adopts an updated list of approved Federations and their member charities, the City will immediately relaunch the 2022 Annual Drive in accordance with the requirements under the Administrative Code to ensure a successful campaign. The Annual Fund materials and donor guide will be updated to specify that the City does not endorse any listed charity and remind employees that they are responsible for ensuring that the organization to which they donate aligns with their own individual values and intent; make clear what each Federation's administrative fees are for processing designated donations; and remind employees that they also continue to have the option to donate by "Donor's Choice" if the lists do not include their preferred charities.

Finally, this memorandum recognizes that the Board of Supervisors may also act to amend the Administrative Code requirements in whole or in part. Currently, the Administrative Code requires an annual drive and this memorandum presents an option with that requirement in place. The Board of Supervisors may also consider suspending the Annual Drive or amending the Administrative Code requirements entirely.

Conclusion

We appreciate the Board's partnership and feedback in addressing the concerns raised regarding the 2022 Annual Drive. Under the existing parameters of the Administrative Code, we submit for the Board of Supervisor's consideration a revised list of eligible Federations.

SEC. 16.93. ORGANIZATIONS FOR WHICH DEDUCTIONS CAN BE MADE.

Deductions and collections as provided by this Article shall be made for the organizations and the purposes designated in the following paragraphs:

(a) Bona fide unions or employee organizations, for dues or assessments, and for premiums or membership fees for automobile, life, accident, health or disability insurance provided under a group plan by said bona fide unions or employee organizations; and when authorized by memorandum of understanding, voluntary political committee contributions.

(b) San Francisco Firemen Federal Credit Union, for the payment of money to or the purchase of shares in.

(c) San Francisco Police Department Federal Credit Union, for the payment of money to or the purchase of shares in.

(d) Provident Central Credit Union, for the payment of money to or the purchase of shares in.

(e) Recreation and Park Federal Credit Union, for the payment of money to or the purchase of shares in.

(f) San Francisco Federal Credit Union, for the payment of money to or the purchase of shares in.

(g) San Francisco Federated Teachers' Credit Union, for the payment of money to or the purchase of shares in.

(h) San Francisco Railway Employees' Federal Credit Union for the payment of money to or the purchase of shares in.

(i) San Francisco Municipal Shopmen's Credit Union, for the payment of money to or the purchase of shares in.

(j) Golden One Credit Union, for dues or assessments.

(k) San Francisco Bay Area Educators' Credit Union, for the payment of money to or the purchase of shares in.

(l) San Francisco Civil Service Commission, for fees relating to the imprinting and processing of fingerprints.

(m) Fire Department League Athletic Musical Events, for the payment of money to.

(n) San Francisco Employees' Benevolent Association, for the payment of money to.

(o) City and County of San Francisco, for payment to the San Francisco City Services Preservation Fund to reduce the City's deficit and preserve City Services.

SEC. 16.93-1. CHARITABLE DEDUCTIONS AND THE ANNUAL JOINT FUNDRAISING DRIVE.

Deductions from employee pay warrants for charitable organizations shall only be withheld based upon authorizations made by employees in the Annual Joint Fundraising Drive. Each year the City and County of San Francisco shall hold an Annual Joint Fundraising Drive ("Annual Drive") in which its officers and employees are encouraged to participate.

(Added by Ord. 429-88, App. 9/16/88)

SEC. 16.93-2. SELECTION OF AGENCIES ELIGIBLE TO PARTICIPATE IN THE ANNUAL JOINT FUNDRAISING DRIVE.

Participation shall be limited to any Mayor's fund which is created to further social causes, those funds being the Mayor's Youth Fund, the Mayor's Homeless Fund, and the Mayor's Youth Employment Summer Program, and to all federated agencies that meet the following criteria, as determined by the Board of Supervisors:

(a) An eligible charitable agency must be a federated agency representing 10 or more charitable organizations, of which at least 50 percent shall represent organizations located in the counties of San Francisco, San Mateo, Santa Clara, Alameda, Contra Costa, and Marin.

(b) The federated agency or Mayor's fund must certify to the Board of Supervisors that the Federal Internal Revenue Service has determined that contributions to all of the represented charitable organizations or Mayor's funds are tax deductible.

(c) The federated agency must have been in existence with 10 or more qualified charities for at least one year prior to the date of application and provide satisfactory evidence to that effect at the time of filing an application with the Board. Mayor's funds shall submit their most recent financial statement to the Board of Supervisors on an annual basis.

(d) The federated agency must submit its most recent certified audit at the time of filing an application with the Board.

(e) Agencies that wish to participate in the Annual Drive are required to submit applications to the Board of Supervisors that include all information that may be relevant to the criteria listed in this Section.

SEC. 16.93-3. DUTIES OF THE MAYOR, THE CONTROLLER AND THE DIRECTOR OF ADMINISTRATIVE SERVICES.

(a) The Mayor shall designate the City's Annual Drive Chair. The Chair will be responsible for providing staff support for the Annual Drive that occurs during the Chair's tenure.

(b) The Controller of the City and County of San Francisco shall provide the technical support necessary for the collection and donor designation process.

(c) The Director of Administrative Services of the City and County of San Francisco shall review all applications to participate in the Annual Drives of the City and recommend to the Board of Supervisors whether applicants qualify to participate in the Annual Drive.

SEC. 16.93-4. SCHEDULE OF THE ANNUAL DRIVE.

(a) By March 1st of each year agencies that wish to participate in the upcoming Annual Drive shall submit their applications to participate with the Board of Supervisors. Provided that only for the 2002 Annual Drive, any Mayor's fund that wishes to participate in the 2002 Annual Drive shall submit their request to participate with the Board of Supervisors by April 15, 2002. By March 1st the Mayor shall also designate the Chair for the upcoming Annual Drive.

(b) By March 1st of each year the Chair of the preceding Annual Drive shall report to the Mayor and the Board of Supervisors on the success of the concluded Annual Drive including the level of employee designations to each federated agency.

(c) By May 1st of each year, the Board of Supervisors, by resolution, shall designate those agencies that qualify to participate in the City's Annual Drive for that year. Provided that only for the 2002 Annual Drive, the Board of Supervisors, by resolution, shall designate June 1, 2002, those agencies that qualify to participate in the City's Annual Drive for that year.

SEC. 16.93-5. OBLIGATIONS OF PARTICIPATING AGENCIES.

All participating agencies shall have the following obligations and responsibilities:

(a) All participating agencies will jointly prepare and print all Annual Drive materials, including directories and payroll deduction forms and other related documents, with a Bay Area printer that pays prevailing wages, and will provide adequate numbers of such materials as determined by the agencies. The Chair of the Annual Drive and the Controller will work with the participating agencies in the design of these materials, the design to be approved no later than August 1st. The Chair of the Annual Drive shall schedule the distribution of materials and associated promotional activities such that all employee payroll deduction authorizations are provided to the Controller no later than December 1st.

(b) All participating agencies and the City and County shall jointly execute a Memorandum of Agreement concerning the payment of actual costs of the Annual Drive materials, and including any additional terms and conditions the Mayor or his or her designee determines, after consultation with the City Attorney, are in the best interest of the City. The memorandum shall also designate which of the participating agencies shall serve as the coordinating agency.

(c) All warrants issued for Annual Drive payroll deductions shall be issued by the City and County to each participating agency based upon the percentage of cash, checks and pledges designated for each participating agency at the conclusion of the solicitation period of the Annual Drive. The distribution percentage shall be provided to the Controller by the coordinating agency. Distribution of funds to the participating agencies by the Controller of the City and County shall occur within five working days after each regular employee payday.

(d) Employee payroll deductions to a given federated agency shall not be made for less than \$1.00 per pay period, and the authorization for any deduction shall be for 12 months. The sum of an employee's authorizations shall be withheld as a single Annual Drive deduction in the Controller's payroll system.

(e) Payroll deduction privileges shall be reviewed annually to determine if all agencies accorded deduction privileges continue to meet the above criteria.

(f) The City and County of San Francisco, after each pay period, shall charge a processing fee of six cents per employee who had an Annual Drive deduction in the payroll period to reimburse the City and County for the expenses incurred in processing payroll deductions as a part of the Annual Drive. The processing fee will be netted out of the warrant issued to the participating agencies following each payroll period. The Controller may change the processing fee each fiscal year in conformance with Section <u>16.92</u> of this Code.

Thank you for the opportunity to appeal for the inclusion of international charities in the City and County of San Francisco's Heart of the City Combined Charities Campaign.

Global Impact has participated as a federation representing and promoting global causes in the Heart of the City Combined Charities Campaign since 2014. By including Global Impact's member charities in the Combined Charities Campaign (CCC), City and County of San Francisco employees have been able to raise over \$450,000 for charities working in important cause areas like global health, refugees, human trafficking, women and girls, hunger, clean water, disaster relief, education and more.

Employee giving campaigns are built to offer employees choices so they can support the causes and charities that mean the most to them. By restricting the CCC to only local organizations, the variety of cause areas being promoted in your campaign and to your employees will be significantly reduced. San Francisco is a diverse city whose residents have global connections and interests. Your employees have proven they care deeply about global causes by pledging thousands of dollars each year to international charities in the CCC.

With Global Impact's charity list being globally focused, we would be excluded from participating in the campaign under the new proposed restrictions stating that charities must be headquartered, have offices in or serve the San Francisco Bay region.

Listed below is the impact on the Heart of the City campaign if Global Impact is excluded. Employees would lose access to support:

- 57 leading international charities including UNICEF, Oxfam, Save the Children and more
- 28 charities who are responding in Ukraine including World Food Program USA and International Rescue Committee
- 42 charities who have been leading relief and recovery efforts in response to COVID-19 including CARE and International Medical Corps
- 8 charities who have responded to California wildfires including Americares and Project HOPE



We respectively ask the Board of Supervisors to consider making an exception to their proposed local charity requirements for charities serving international causes and populations. Attached please find supporting documents related to our appeal, including:

- a. Global Impact's proposed charity list that aligns with San Francisco's values and interests. We collect signed non-discrimination policies from each of our charity members on an annual basis.
- b. Sample language of other workplace giving campaigns who have made exceptions for international charities in their programs

Attachment B: Eligibility Examples

Public Sector Campaigns with Local Presence Eligibility Requirement

*Please note the campaigns listed all refer to **state-government** campaigns or **municipal-government** campaigns, that have a requirement for local presence to be eligible to participate.

- 1. Alabama SECC (state)
 - a. Organizations must be directed by an active local board, which meets at least quarterly, whose members serve without compensation (for organizations where a paid executive director or other staff member is a member, volunteers must constitute the majority of the board), and whose members are residents of the local geographic region served.
 (Organizations serving the needy overseas are exempt from the local geographic region served.)
 - b. Ala. Code § 36-1A-5: Such services must be available to state employees in the local campaign community, unless they are rendered to needy persons overseas. Such services must directly benefit human beings, whether children, youth, adults, the aged, the ill and infirm, or the mentally or physically handicapped. Such services must consist of care, research, or education in the fields of human health or social adjustment and rehabilitation; relief for victims of natural disasters and other emergencies; or assistance to those who are impoverished and in need of food, shelter, clothing, and basic human welfare services.
- 2. Arizona SECC (state)
 - a. Demonstrate a direct and substantial presence in the local community. This is defined as an organization that has a staffed facility, office, or portion of a residence located in Arizona, and is dedicated to that organization and makes its services or benefits available to members of the Arizona community. (International or National level charities shall be exempt from compliance with this requirement.)
- 3. Georgia SCC (state)
 - a. "Eligible voluntary charitable organization" means a charitable organization which:
 - i. (B) a federated charitable organization that provides direct and substantial health and welfare services internationally whose activities do not require a local presence or provision of local services, which is authorized and certified by the Secretary of State to transact business in Georgia,



- 4. Maryland CC (state)
 - A description of services provided for two (2) preceding calendar years to Maryland residents OR If your organization provides services to persons in other countries, a description of services and proof of financial support received from Maryland residents within the past five (5) years.
- 5. Missouri SECC (state)
 - a. I hereby certify the services provided by the organization are accessible to residents of Missouri. (This may not apply to international organizations)
- 6. Oklahoma SCC (state)
 - a. Unless your organization's scope of service is international, we need to know the counties in Oklahoma in which you provide service.
- 7. Texas SECC (state)
 - a. International federations or funds are not required to maintain a physical presence in Texas in the form of an office or facility that is staffed at least 20 hours a week, so that certification box does not have to be checked.
