1	[Josè Sarria Day - December 13, 2022]
2	
3	Resolution declaring December 13, 2022, to be "Josè Sarria Day" in the City and
4	County of San Francisco, in recognition of his significant contributions to San
5	Francisco and LGBTQ+ history, and in celebration of his 100th Birthday.
6	
7	WHEREAS, Josè Julio Sarria was born in San Francisco on December 13, 1922; and
8	WHEREAS, Sarria was openly gay when he served in the military during World War II
9	and was discharged from the U.S. Army in 1947 after rising to the rank of Staff Sergeant; and
10	WHEREAS, After his return home from military service, Sarria paved the way for the
11	LGBTQ+ community, running for the San Francisco Board of Supervisors in 1959 as the first
12	openly gay man to run for elected office in the United States, and in 1962, helping form the
13	Tavern Guild, the country's first gay business association; and
14	WHEREAS, Sarria performed as a drag queen at San Francisco's Black Cat Bar in the
15	Tenderloin and fought against police harassment during homophobic raids on gay bars; and
16	WHEREAS, Sarria founded the Imperial Council of San Francisco in 1965, and the
17	International Court System in 1996; and
18	WHEREAS, The International Court System is a group of 70 affiliated independent
19	charities in the United States, Canada, and Mexico, dedicated to empowering LGBTQ+
20	communities; and
21	WHEREAS, Sarria was a military veteran, artist, community organizer, and more, and
22	dedicated much of his life to transforming, protecting, and advancing the LGBTQ+ community;

24	WHEREAS, December 13, 2022, would have been Sarria's 100th birthday; now,
25	therefore, be it
