WHEREAS, on June 27, 2006, pursuant to the Property and Community Benefit Law of 1994, California Streets and Highways Code Sections 36600 *et seq.* (the "Act"), as augmented by Article 15 of the San Francisco Business and Tax Regulations Code ("Article 15"), the Board of Supervisors adopted Resolution No. 389-06 "Resolution of Intention to form the Fillmore Jazz Community Benefit District (BID)" ("Resolution of Intention"); and,

WHEREAS, on August 15, 2006 the Board of Supervisors adopted Resolution No. 462-06 "Resolution to Establish the Fillmore Jazz Community Benefit District" (Resolution to Establish) for a period of 5 years commencing with fiscal year 2006-2007, with services commencing January 1, 2007 (BOS File No. 061149); and,

WHEREAS, on May 1, 2007 the Board of Supervisors adopted Resolution No. 219-07 "Contract with Owners' Association for Administration of Fillmore Jazz Community Benefit District" (BOS File No. 070465); now, therefore, be it

RESOLVED, that the Board of Supervisors declares as follows:

Section 1. RECEIPT AND APPROVAL OF THE FILLMORE JAZZ COMMUNITY BENEFIT DISTRICT'S ANNUAL REPORTS TO THE CITY.
