3	Ordinance authorizing settlement of the lawsuit filed by Victor Jimenez against the City		
4	and County of San Francisco for \$100,000; the lawsuit was filed on July 20, 2021, in		
5	San Francisco Superior Court, Case No. CGC-21-593613; entitled Victor Jimenez v. City		
6	and County of San Francisco; the lawsuit alleged property damage and personal		
7	injuries arising from a dangerous condition of public property, i.e., a sinkhole that		
8	opened in the roadway underneath plaintiff's vehicle.
