## Good Morning,

Joel Ramos from SFMTA will be there at the Finance Committee today. I've also included some more information about the retroactivity below.

Why is the cost-sharing agreement retroactive?

This agreement provides funding to SFMTA from BART to provide Paratransit services for BART in San Francisco. Paratransit staff efforts at both SFMTA and BART had been focused on responding to the COVID pandemic and we missed that the agreement needed to be renewed. BART staff did not prepare a new agreement until recently, although BART continued to pay under the expired agreement.

## Background:

Under the Americans with Disabilities Act, all public transit agencies providing fixed route service must provide complementary Paratransit services. This would require BART, as a fixed route service provider, to provide complementary Paratransit services in San Francisco. In lieu of BART providing Paratransit services in San Francisco, since 1994, SFMTA, through the SF Paratransit program, has provided complementary Paratransit service to ADA riders for trips within San Francisco. SF Paratransit serves the entire area in San Francisco that BART would have otherwise had to provide Paratransit services for. This cost sharing agreement outlines the reimbursement formula to SFMTA for providing Paratransit services on behalf of BART. BART pays for approximately 7.9% of the annual Paratransit cost of the SF Paratransit program.
