An appeal of Adjustment, Reduction, or Waiver of Development Project Requirements regarding the Community Infrastructure Fee (Planning Code, Sections 421 and 428) for a proposed religious worship building project at 245 Valencia Street was filed with the Office of the Clerk of the Board on December 19, 2022, by Paul P. Sogotis, on behalf of the United Greek Orthodox Community of San Francisco, The Annunciation Greek Orthodox Cathedral.

Pursuant to Planning Code, Section 406, a sponsor of any development project subject to a development fee or development impact requirement imposed by Planning Code, Article 4, may appeal to the Board of Supervisors for a reduction, adjustment, or waiver of the requirement based upon the absence of any reasonable relationship or nexus between the impact of development and either the amount of the fee charged or the on-site requirement. Such filing shall be made in writing no later than 15 days after the date the Department or Commission takes final action on the project approval that assesses the requirement.

I am forwarding the appeal, with attached documents, to the Planning Department and the Building Inspection Department, to determine if the documents are sufficient for filing and that the appeal has been filed in a timely manner. The determination should be made within three (3) working days of receipt of this request.
