CERF PURPOSE

<u>The Community Economic Resilience Fund (CERF)</u> will create regional, **highroad economic development plans to create equitable access to quality jobs.** High-road economic development supports environmentally sustainable businesses that pay living wages and create opportunities for career growth. As California recovers from the economic distress of COVID-19, CERF aims to ensure that the state's economy works for all California residents, particularly those who have historically been marginalized.









Phase I Planning Grant (\$5 million):

- Form Bay Area High Road Transition Collaborative (BA-HRTC).
- Conduct research on best practices and regional needs.
- Create regional economic and workforce development plan.
- Program Period: October 1, 2022 September 30, 2024

Phase II Implementation Grants (up to \$500 million):

- Implement regional economic and workforce development plan.
- Identify regional economic diversification pilot projects and apply.
- Identify regional workforce development program projects and apply.
- Rolling Applications: January 1, 2023 September 30, 2026

BA-HRTC GOVERNANCE STRUCTURE

Regional Convener (All Home) & Fiscal Agent (**BAGJPE) -** *Day-to-day decision-making, compliance, and reporting.*

Steering Committee (21 Members) - Includes community, labor, business, environmental, government, workforce, and educational representatives to provide strategic direction and oversight.

Research Planning and Outreach Committee - *Oversees data gathering, analysis, and engagement strategy.*

Sub-Regional Tables - *Identifies regional needs and recommends pilot projects.*



CERF FISCAL LEAD RESPONSIBILITIES (SFOEWD)

- Oversee day-to-day operations of the grant.
- Liaison to CA EDD, OPR, LWDA, and GO-Biz.
- Manage reporting and performance requirements.
- Distribute funds and manage procurements.
- Oversee compliance, including reporting, accounting, disclosures.
