10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Victor Jimenez v. City and County of  
13 San Francisco, San Francisco Superior Court, Case No. CGC-21-593613 by the payment of  
14 \$100,000. The lawsuit involves **alleged property damage and personal injuries arising**  
15 **from a dangerous condition of public property, i.e., a sinkhole that opened in the**  
16 **roadway underneath plaintiff's vehicle.**

17 Section 2. The above-named action was filed in San Francisco Superior Court on July  
18 20, 2021, and the following parties were named in the lawsuit: Victor Jimenez, plaintiff; City  
19 and County of San Francisco, defendant.
